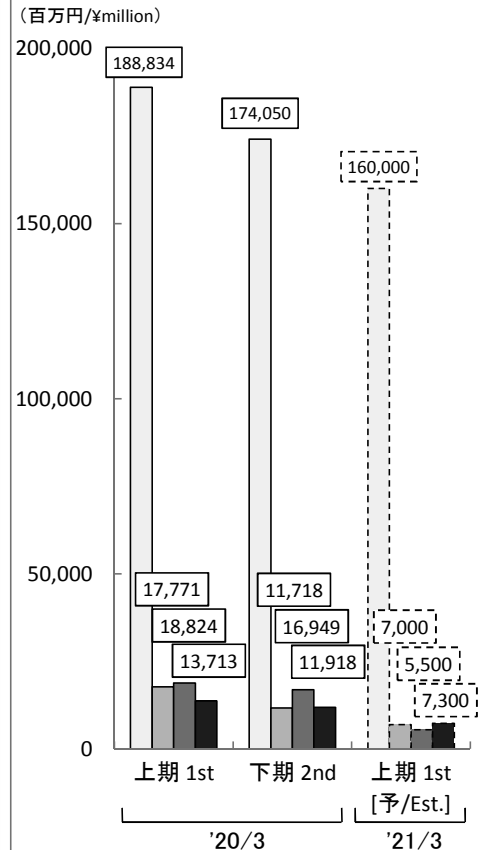

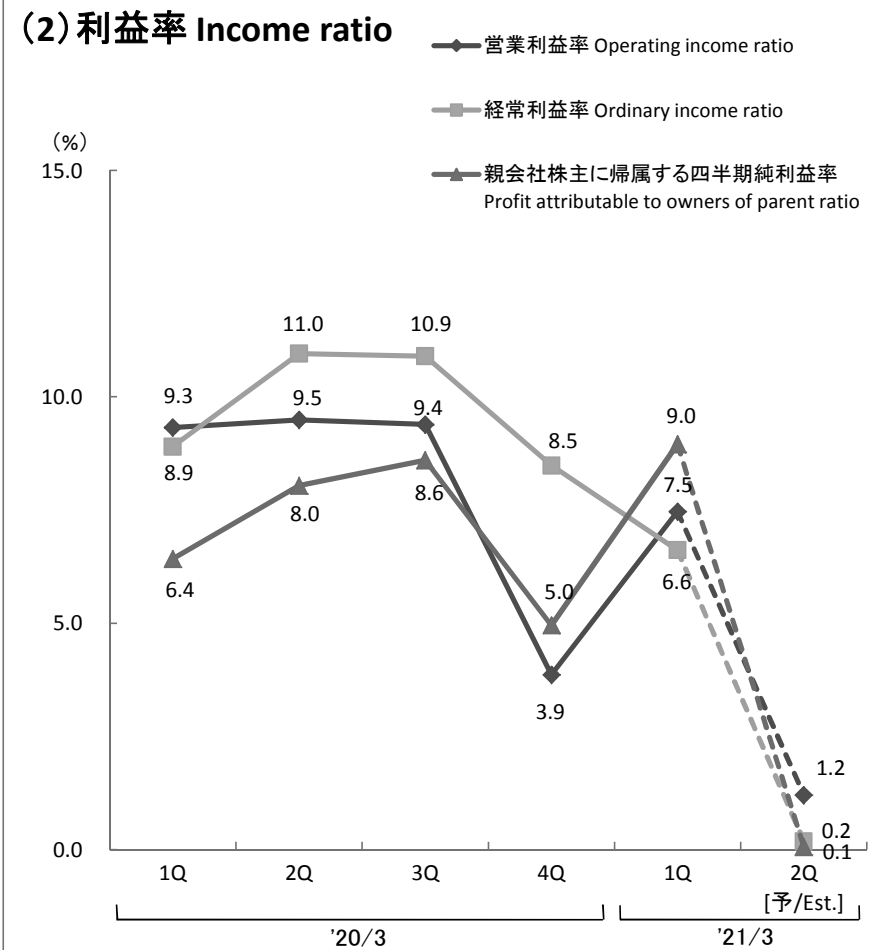

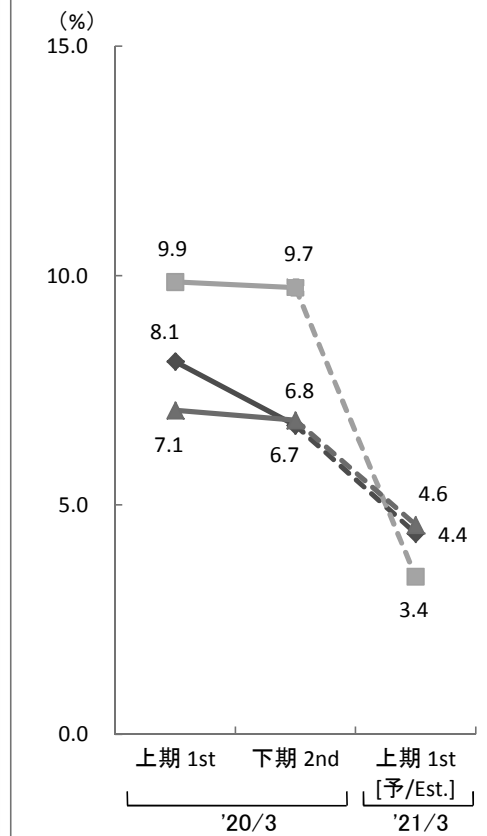
半期別推移 Half period trend

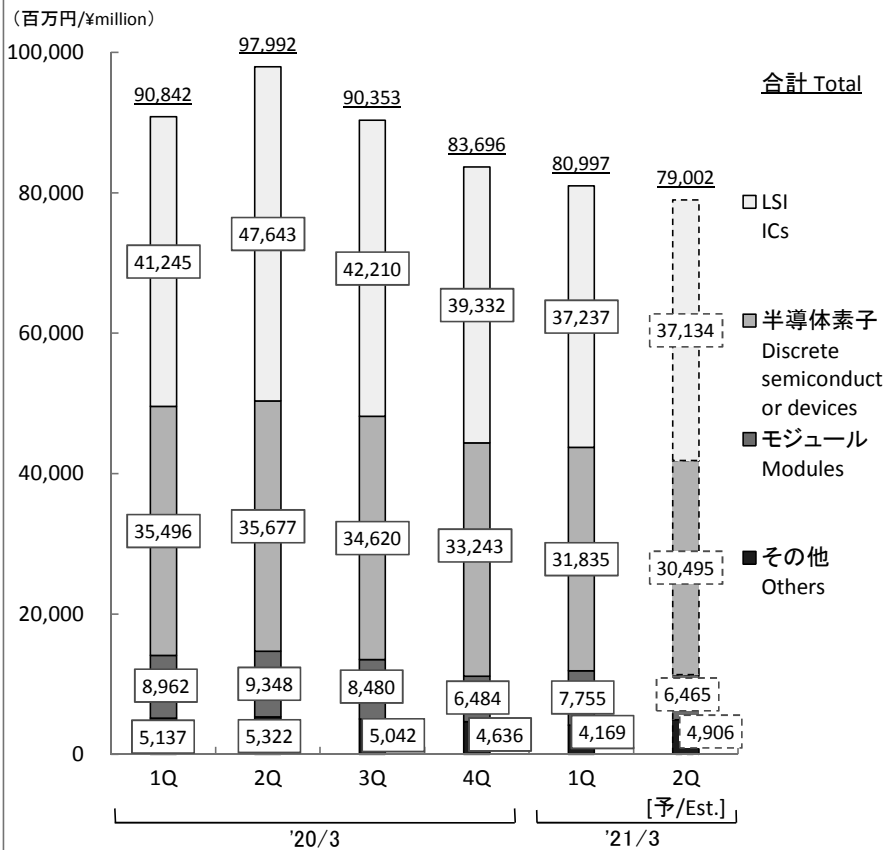

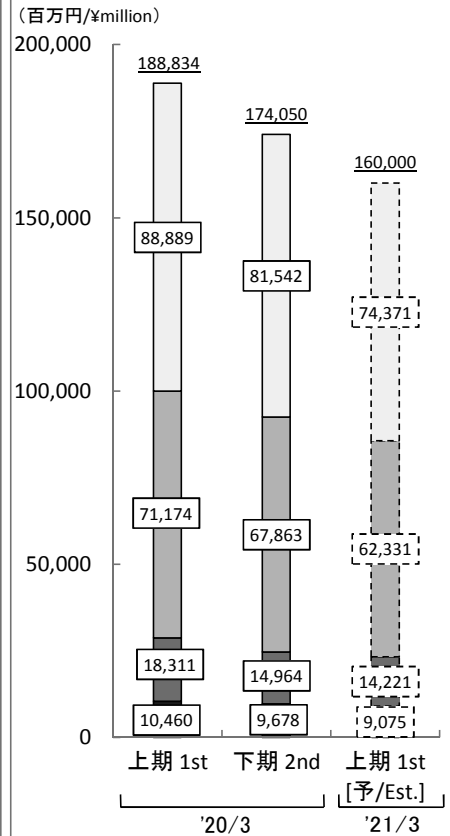

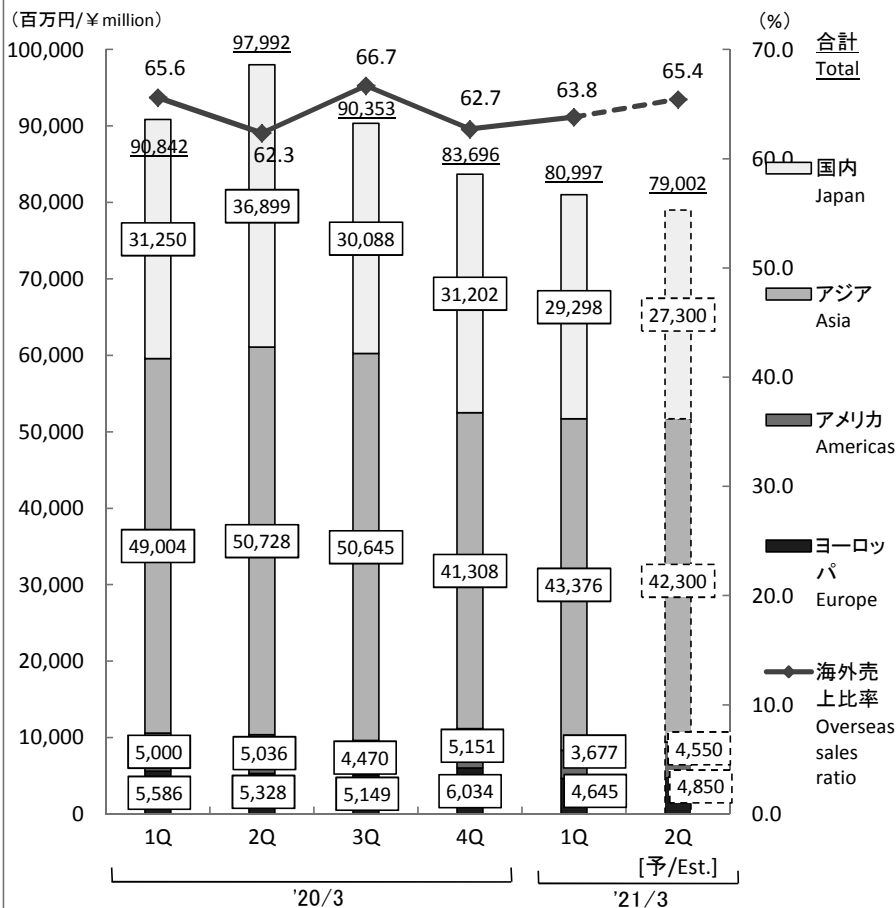
(1)セグメント別売上高 Sales by segment



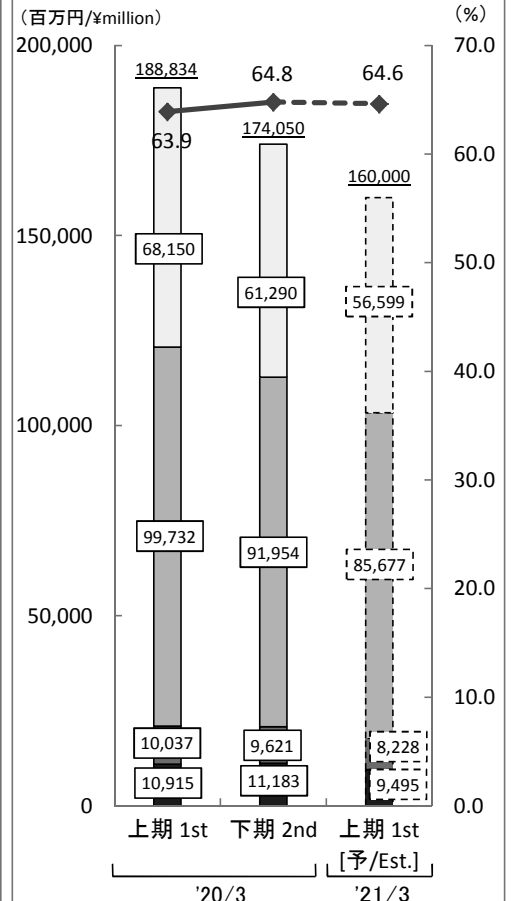

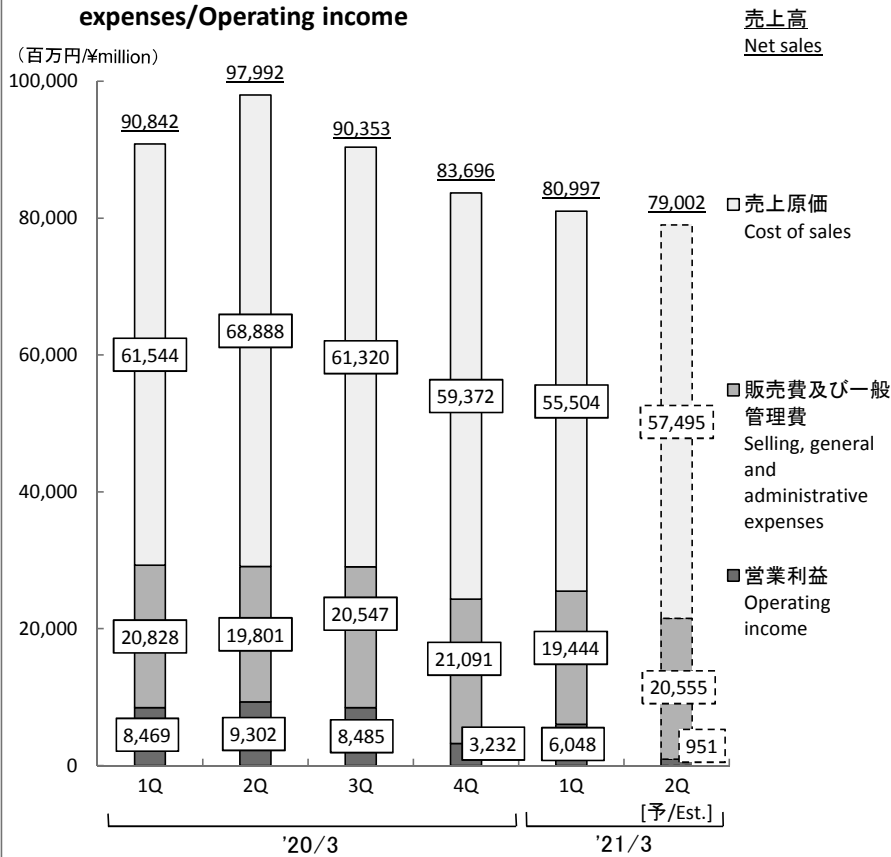

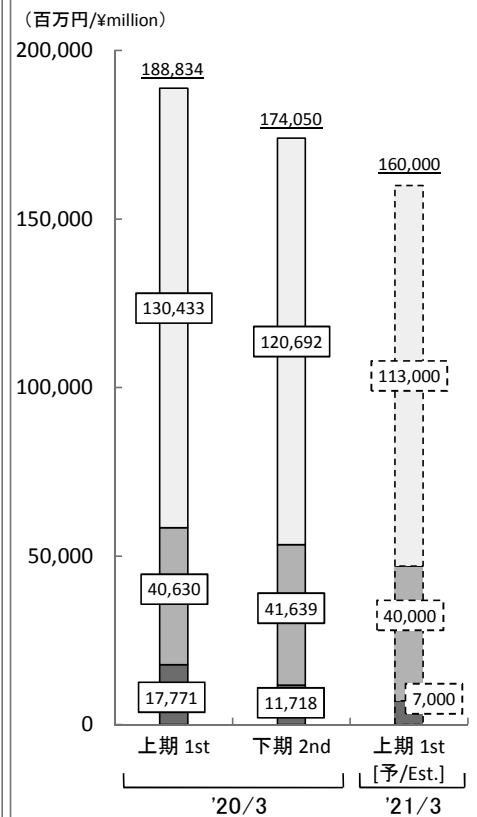

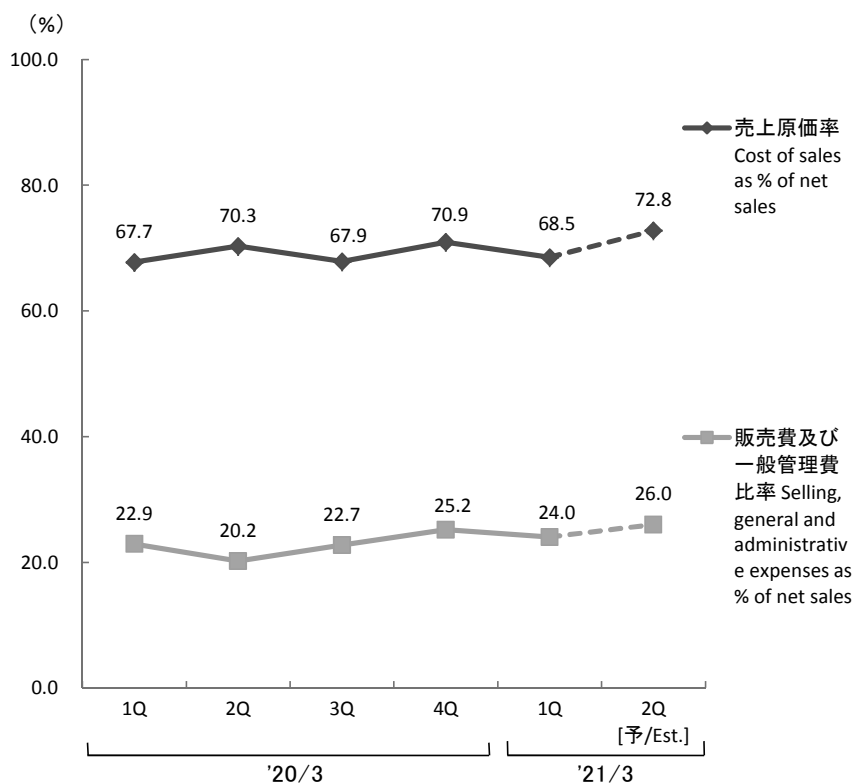

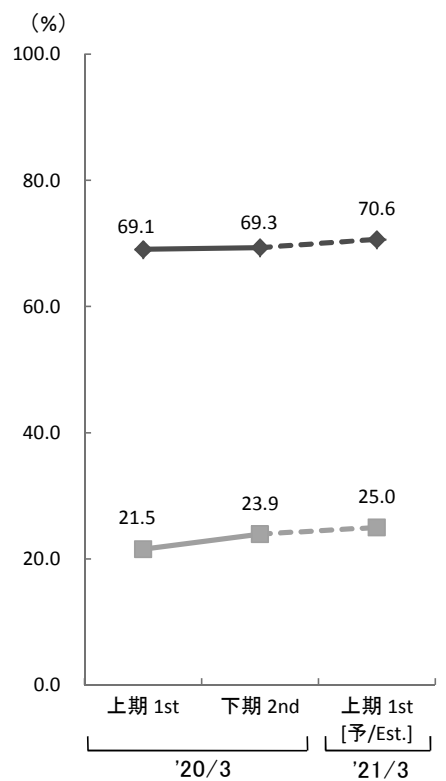
(2) 売上原価率・販売費及び一般管理費比率

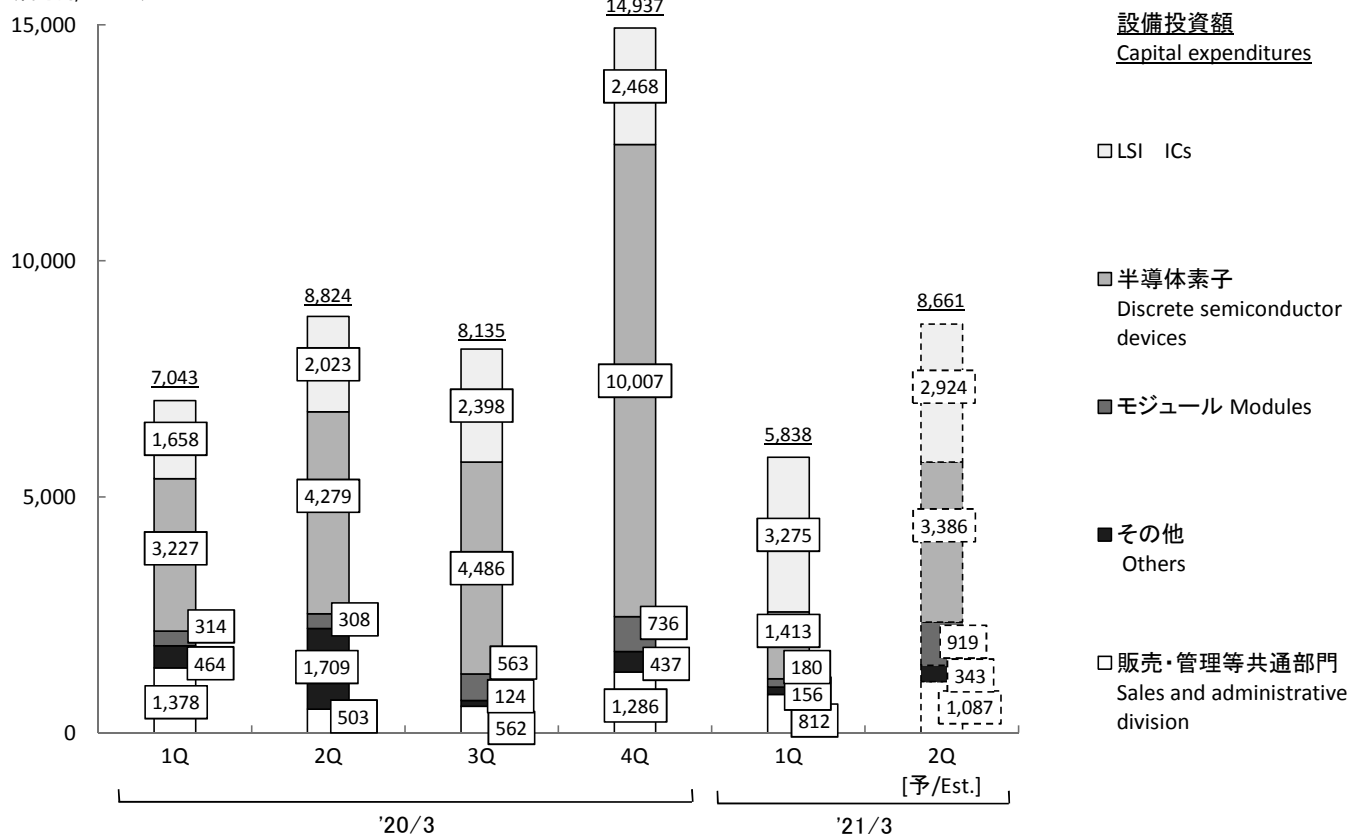

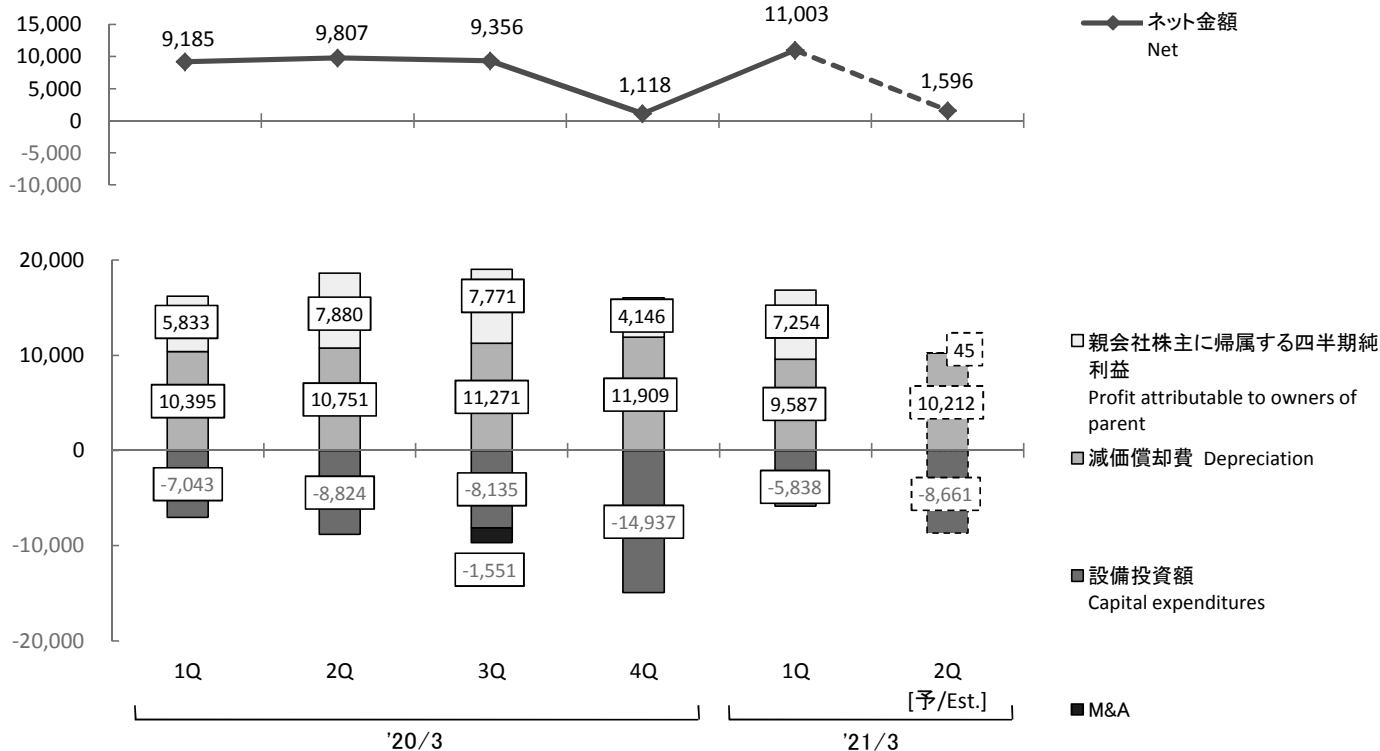

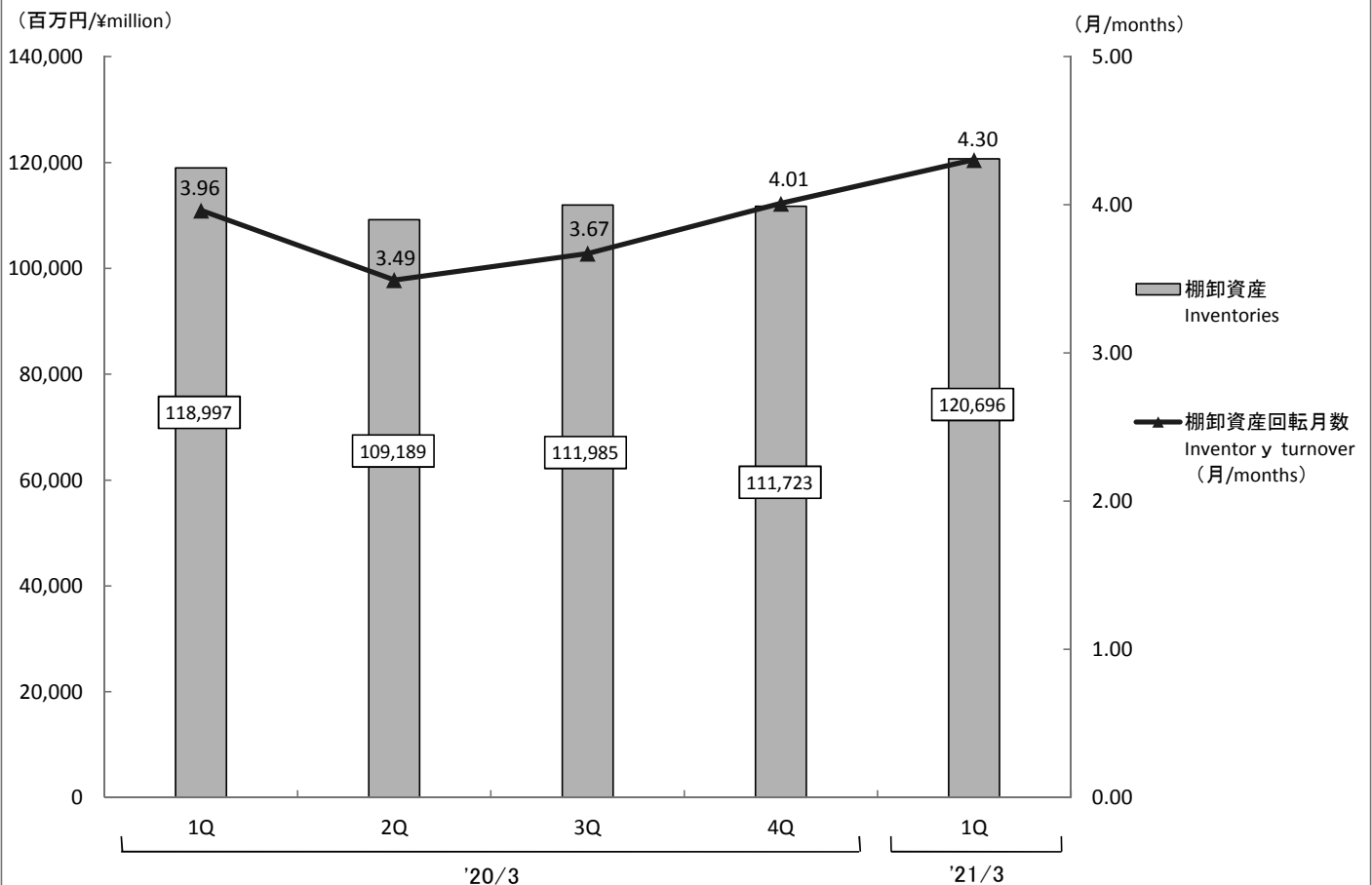

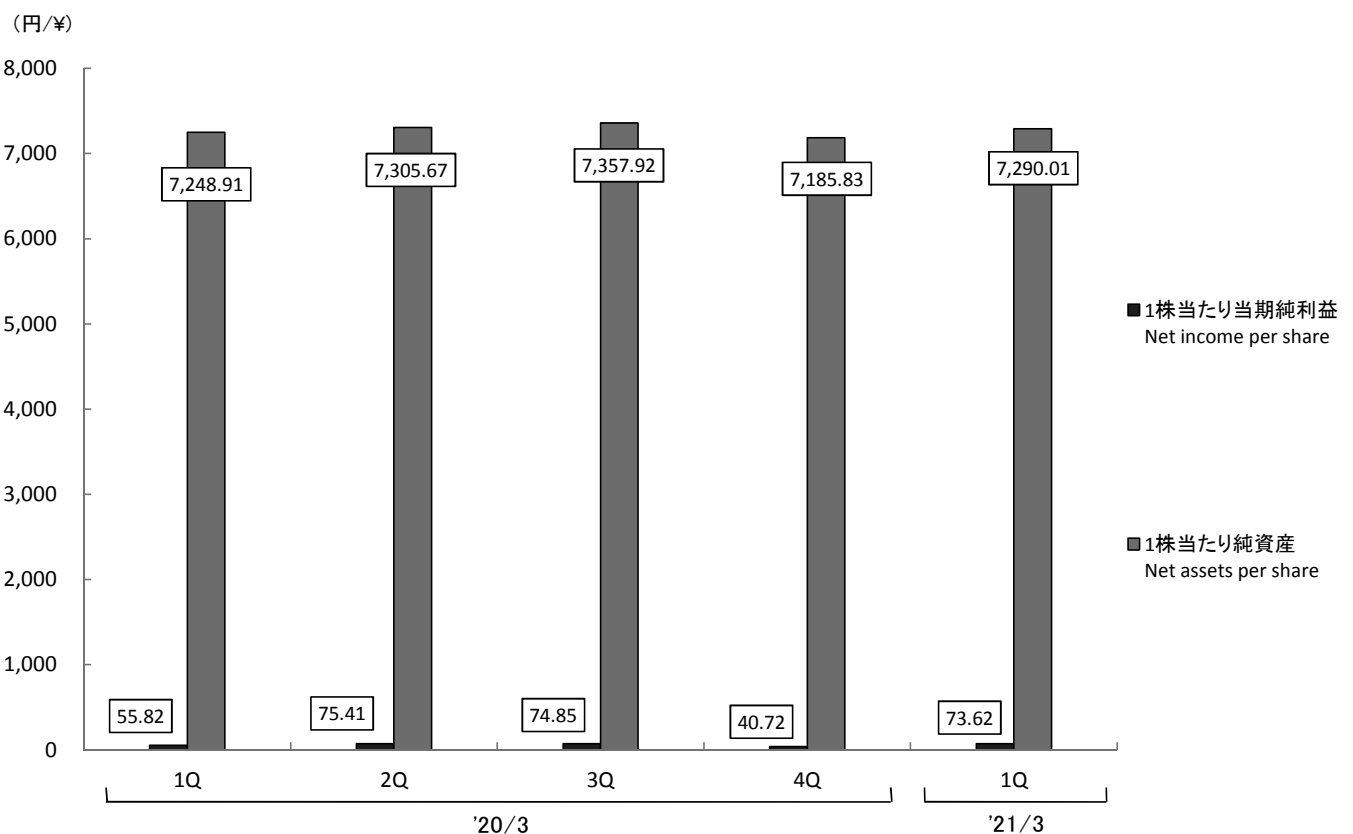
