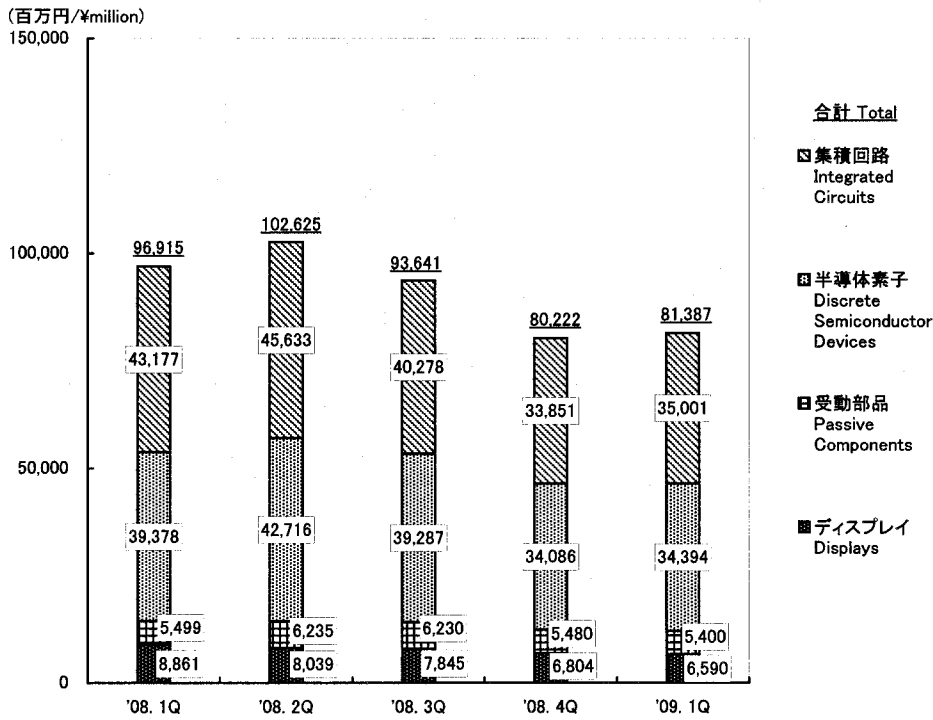

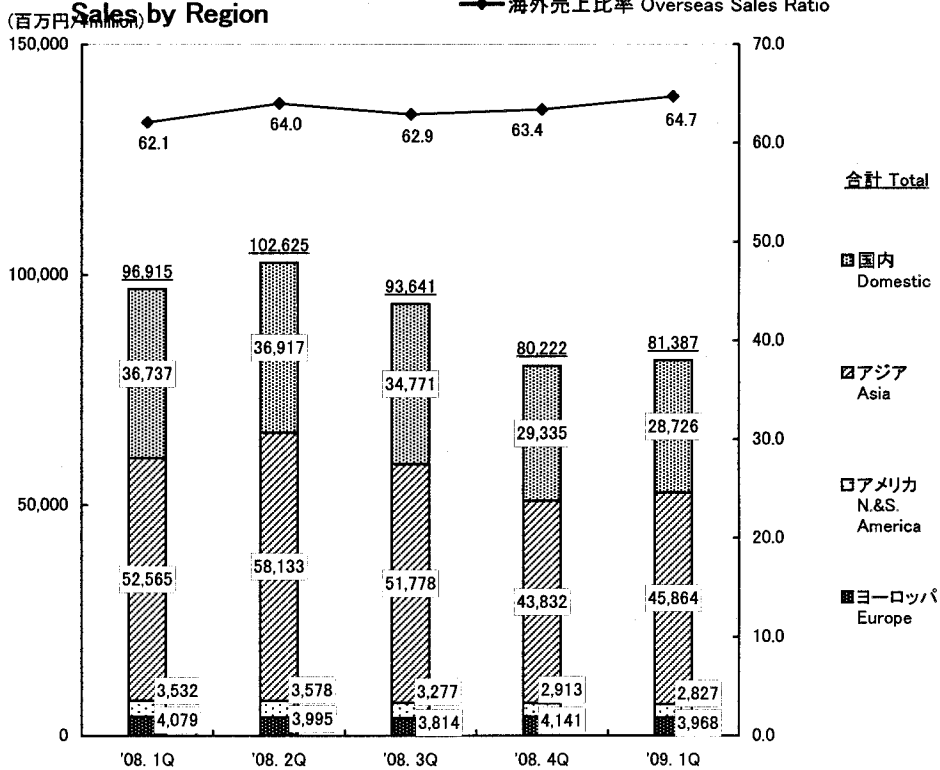
(1)部門別売上高
Sales by Product Category



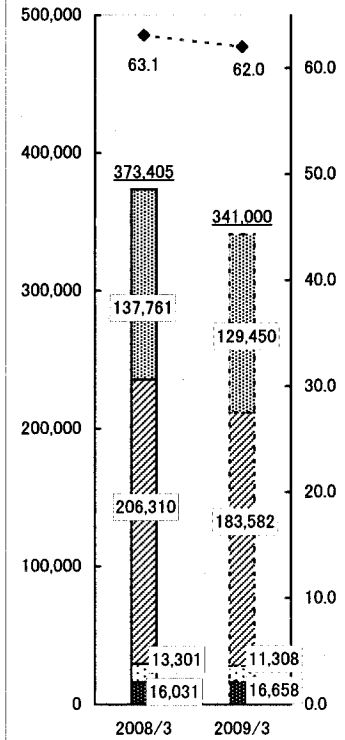
通期別推移

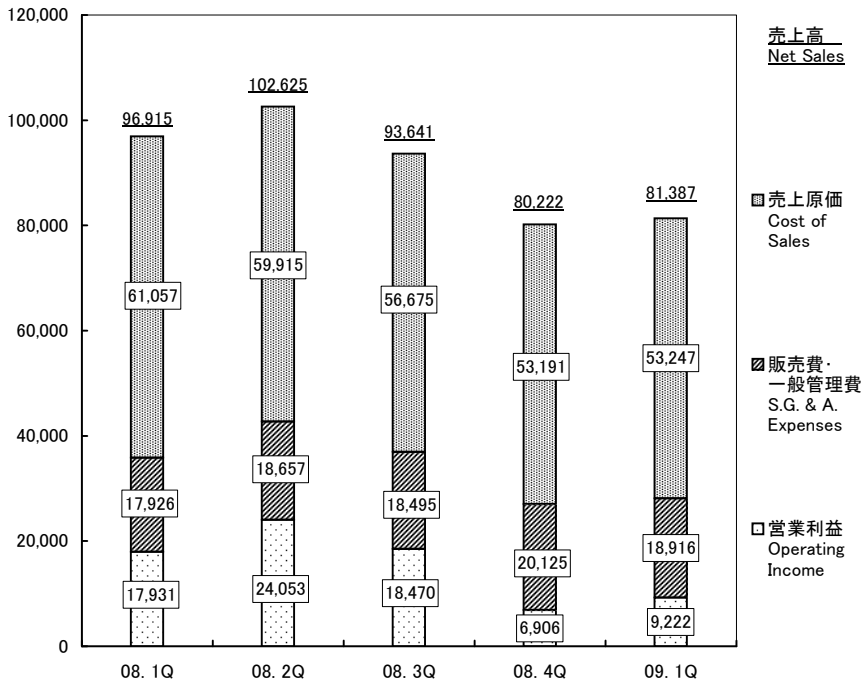

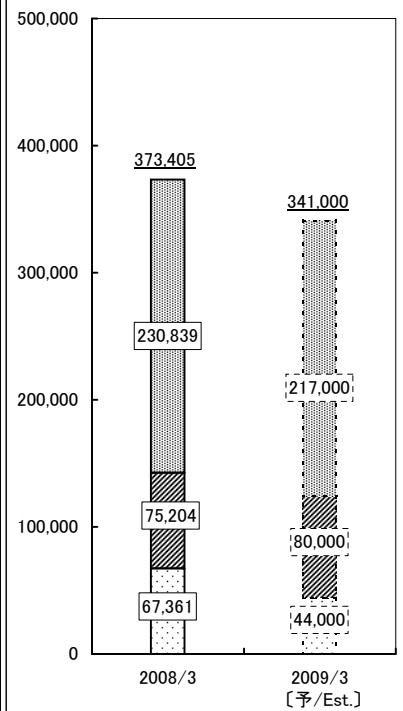

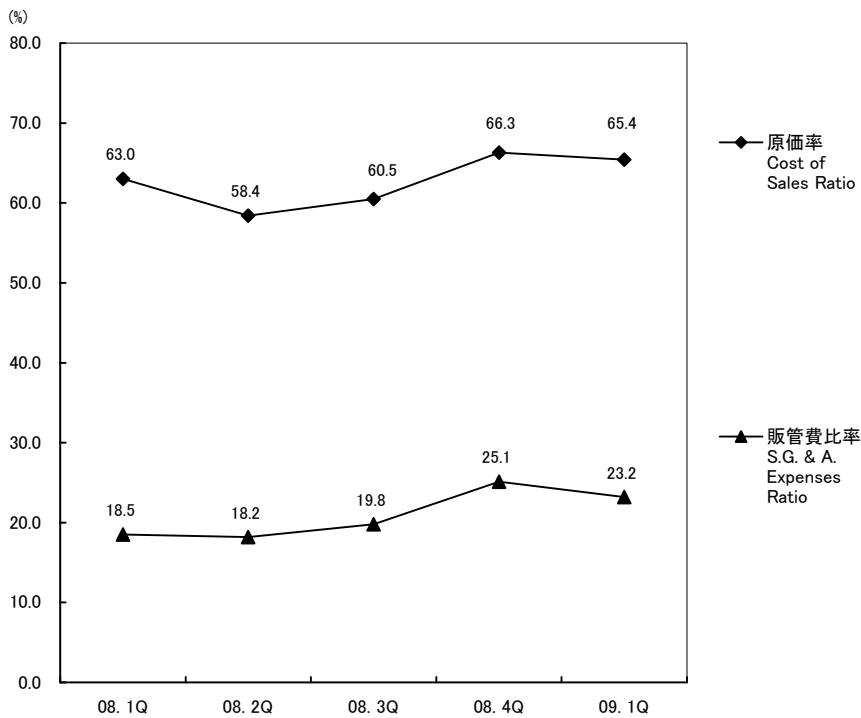

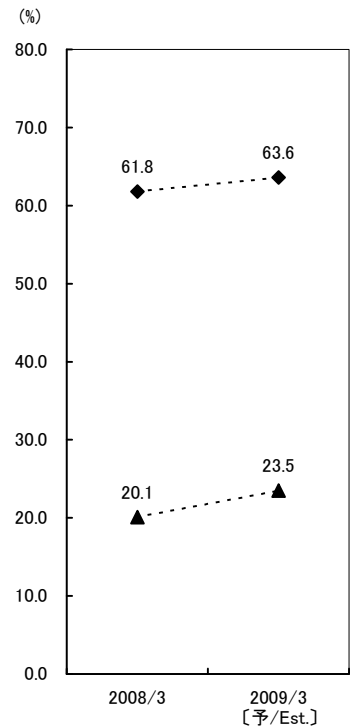
通期別推移 Annual Trend



(2) 売上原価率・販管費比率



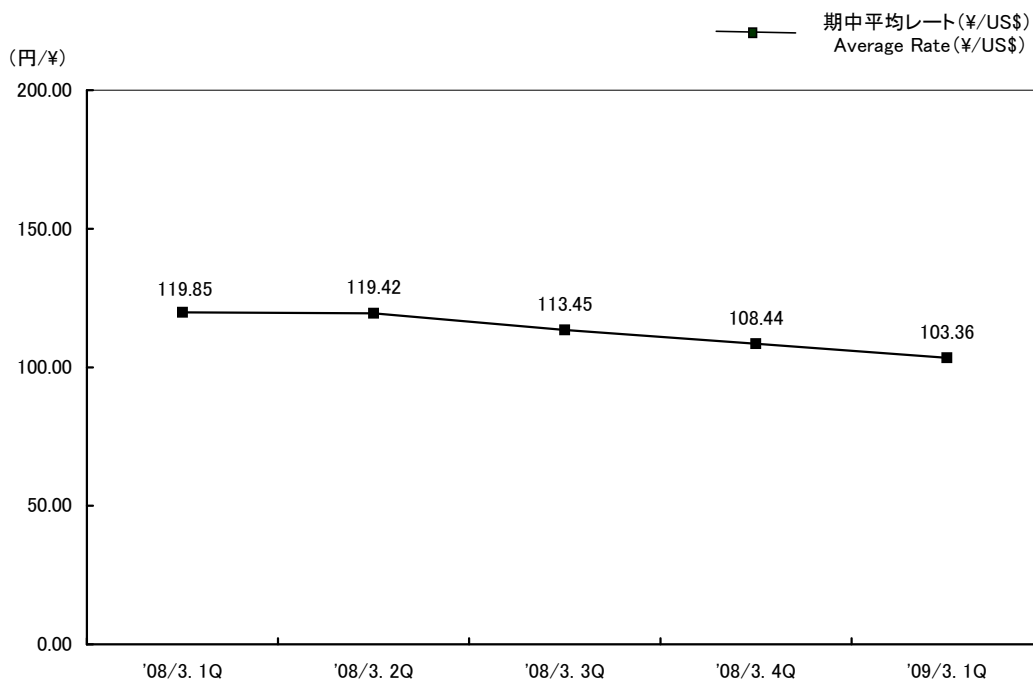
通期別推移 Annual Trend



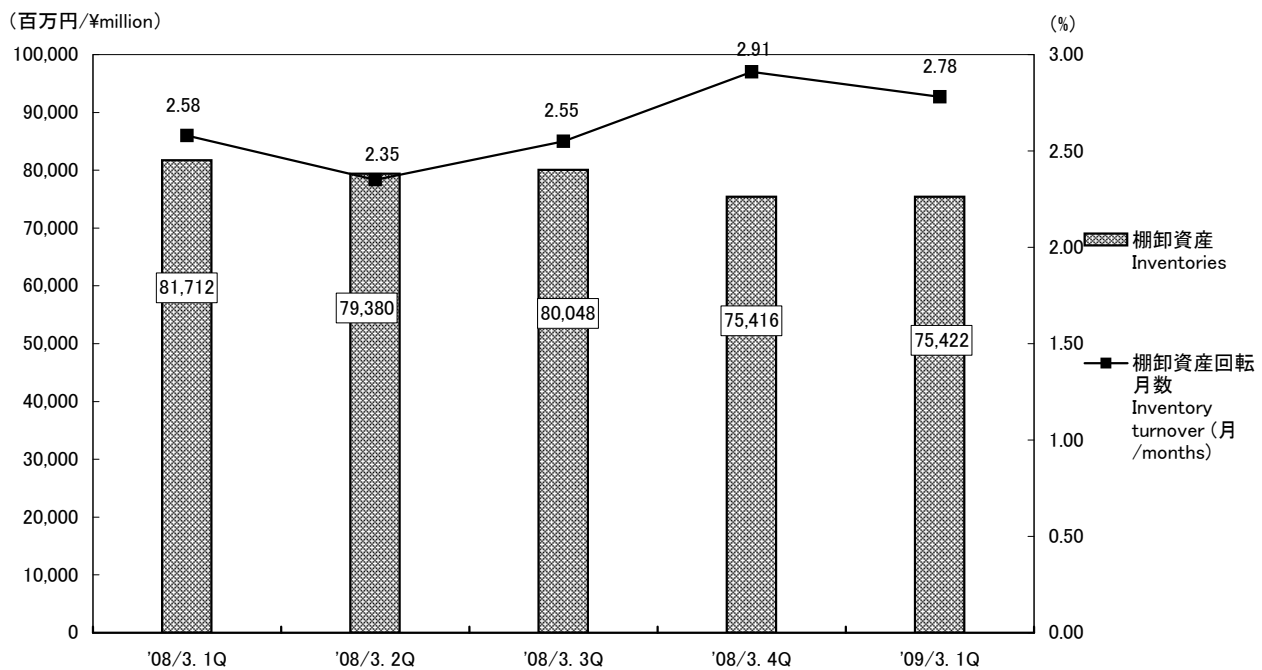

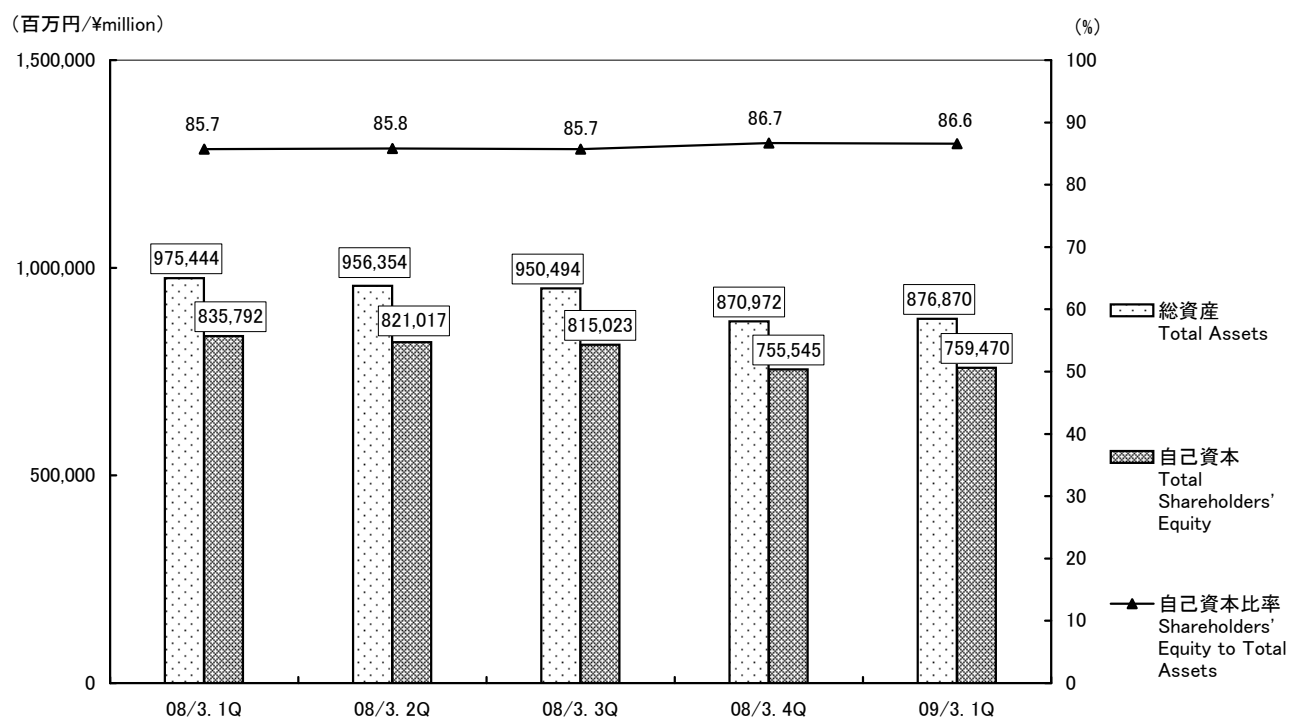

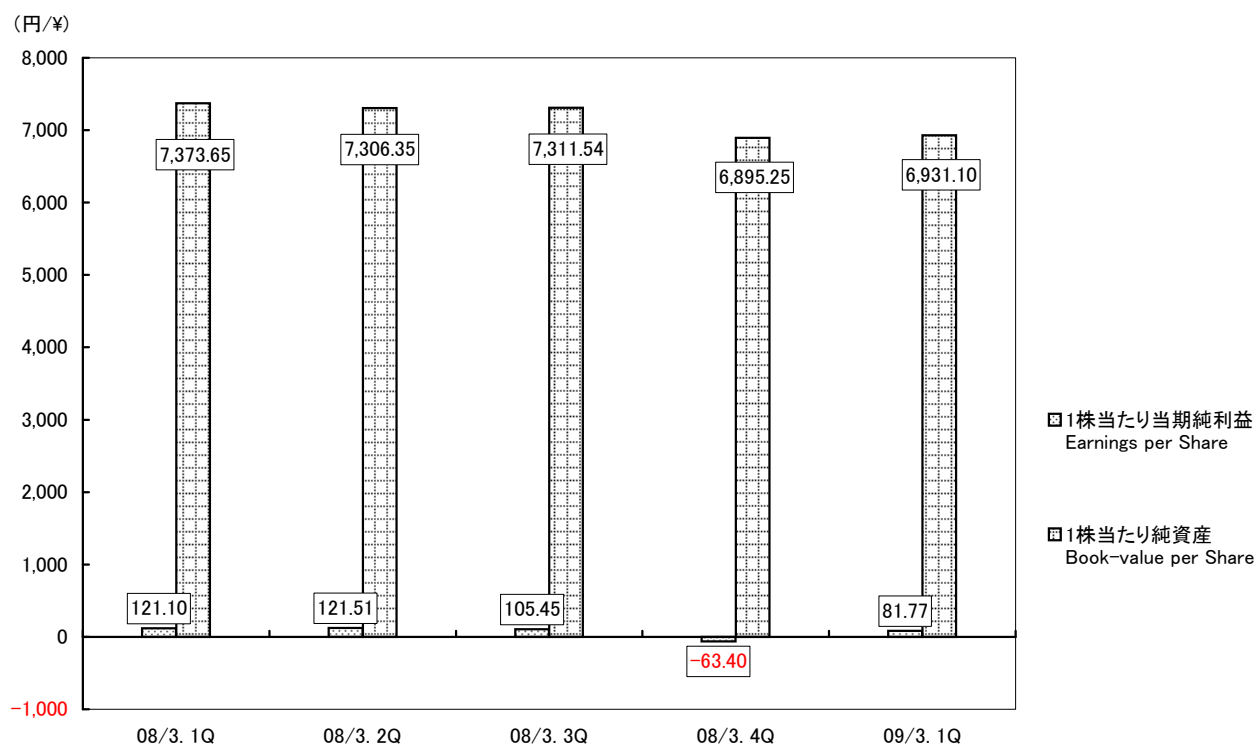
