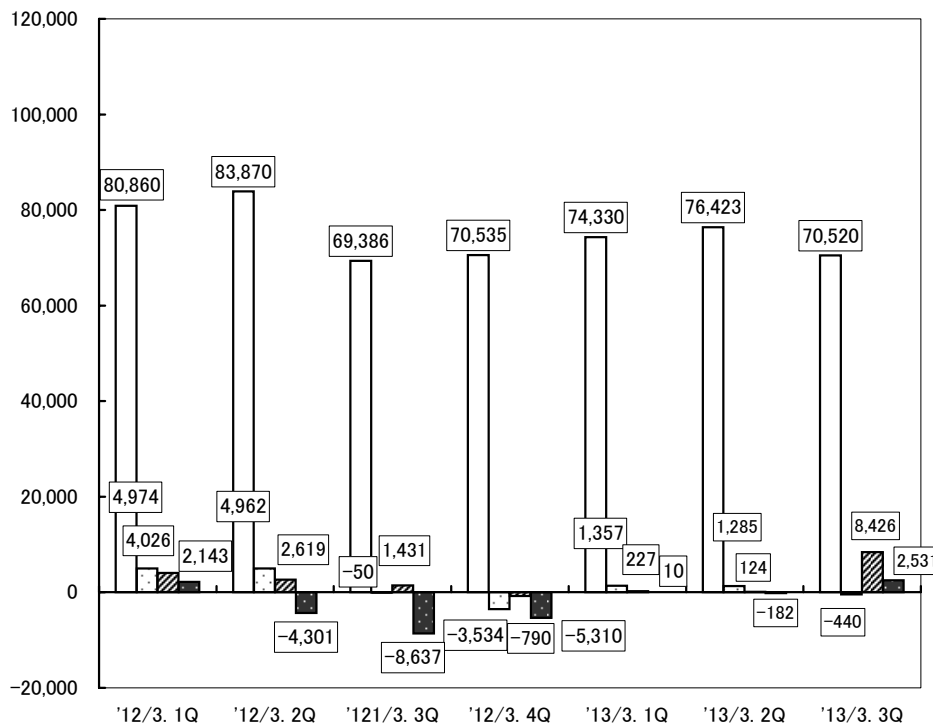

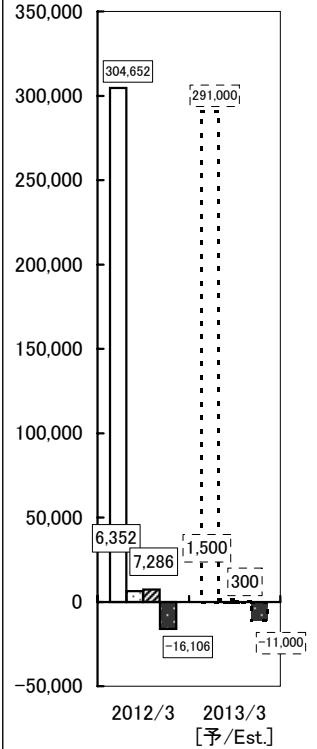

通期別推移 Annual Trend

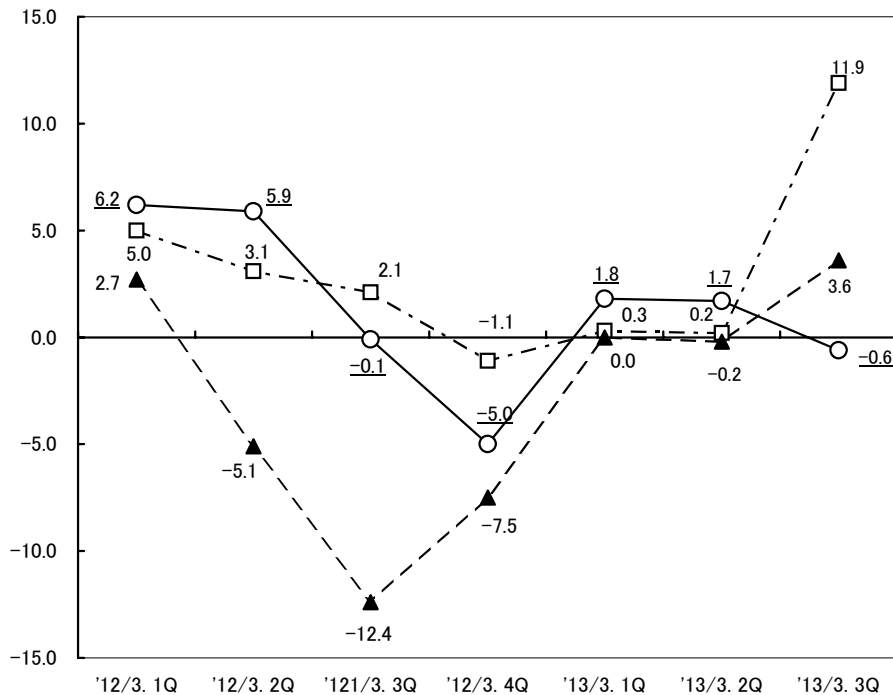

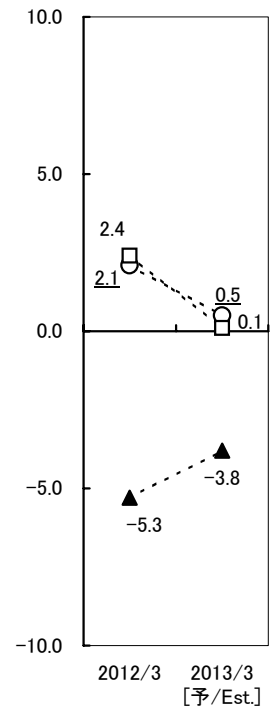

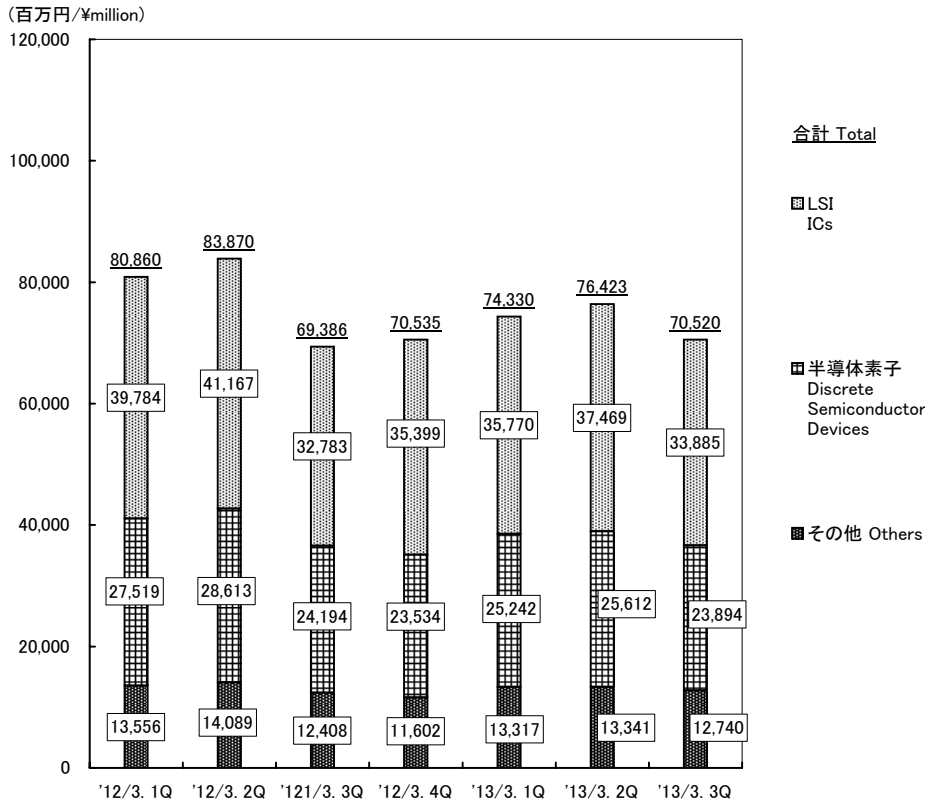

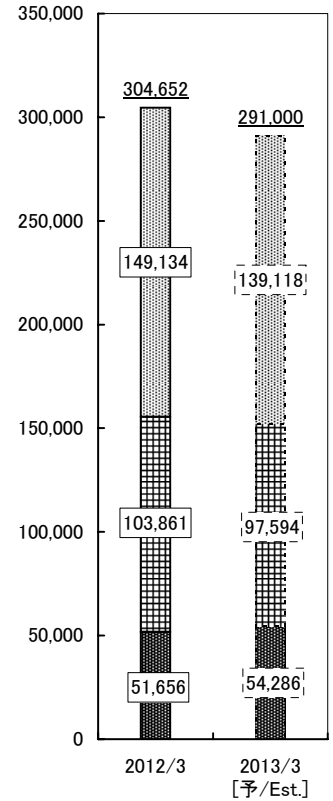
(1) セグメント別売上高 Sales by Segment



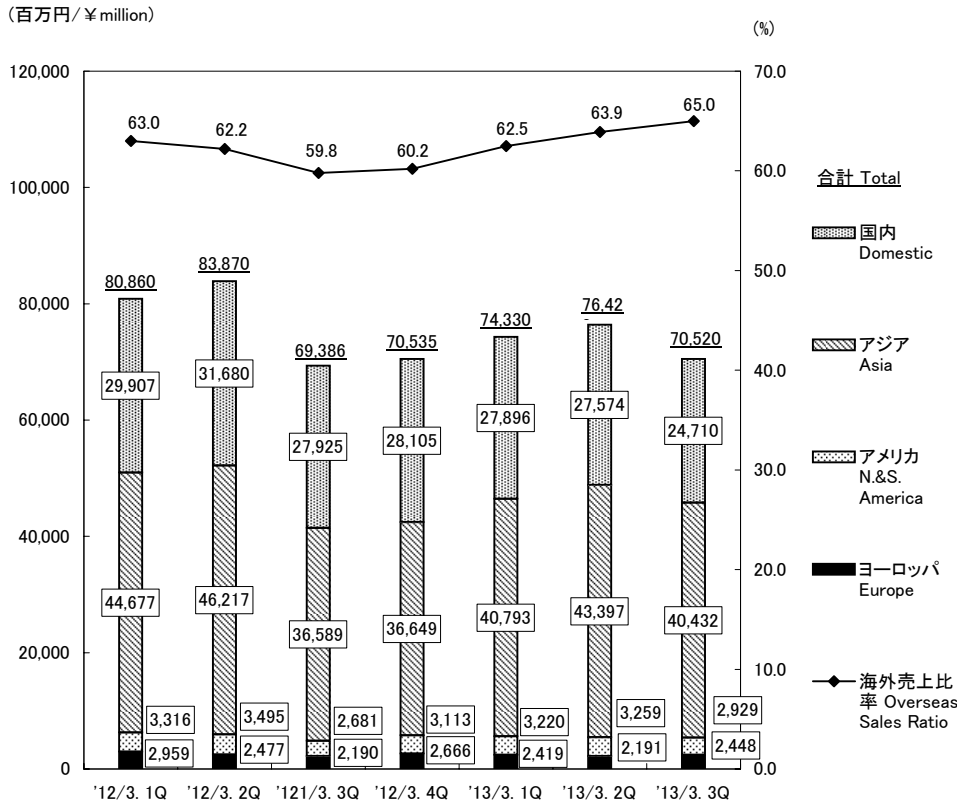

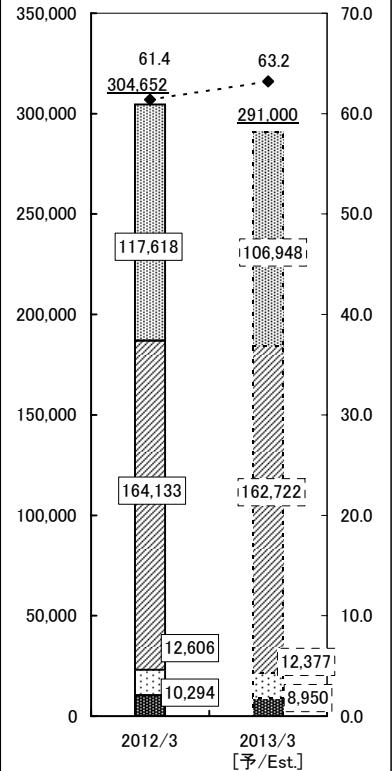


(2) 地域別売上高 Sales by Region

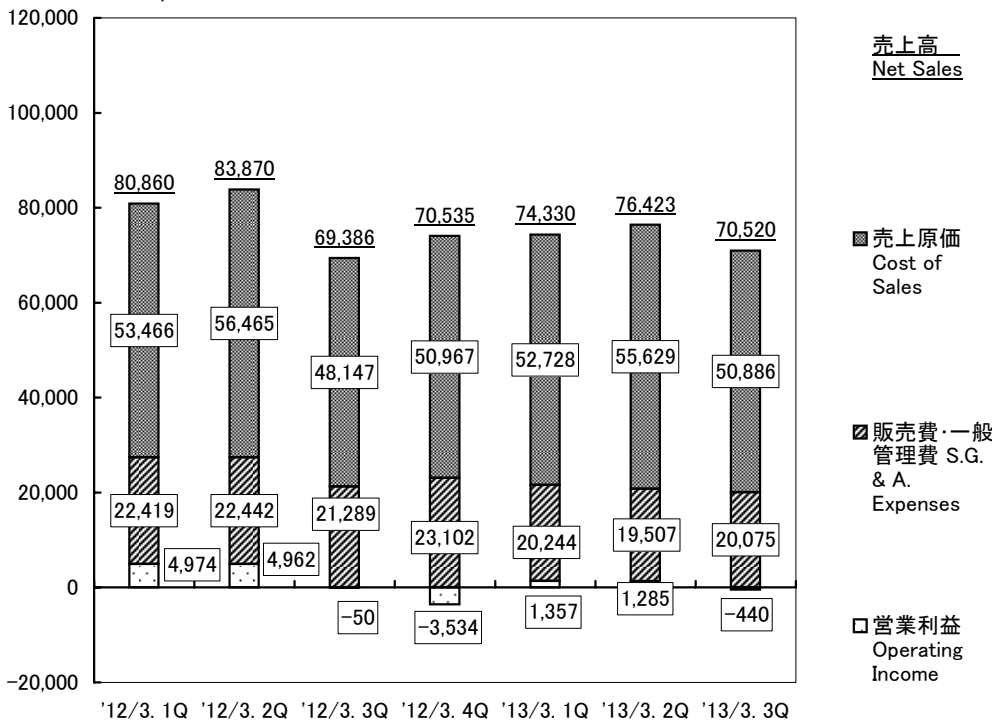

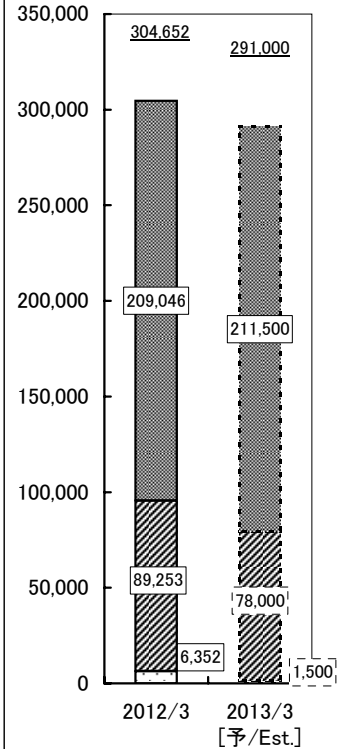

通期別推移 Annual Trend

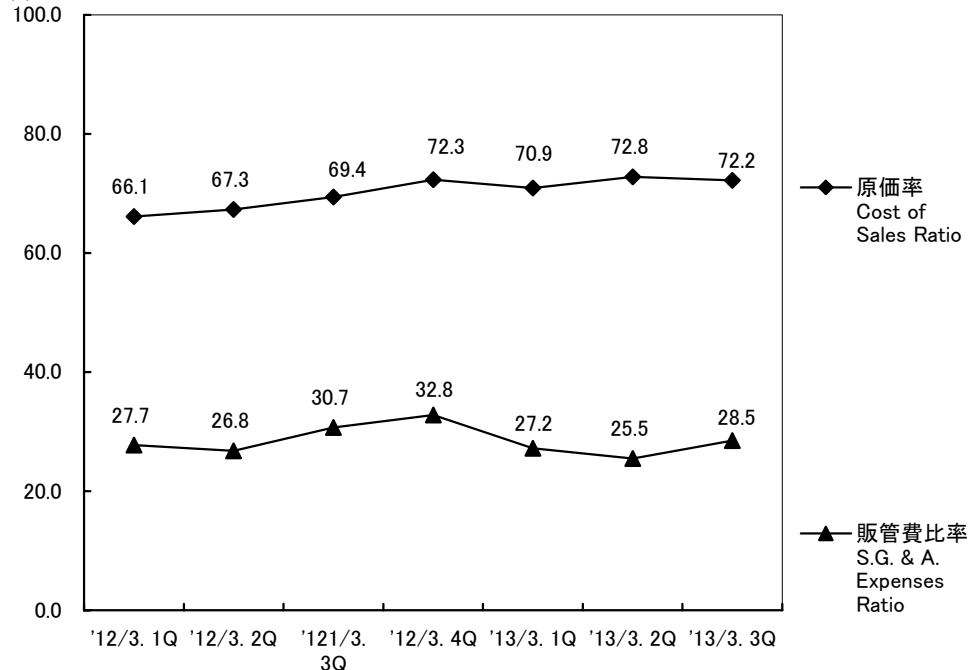

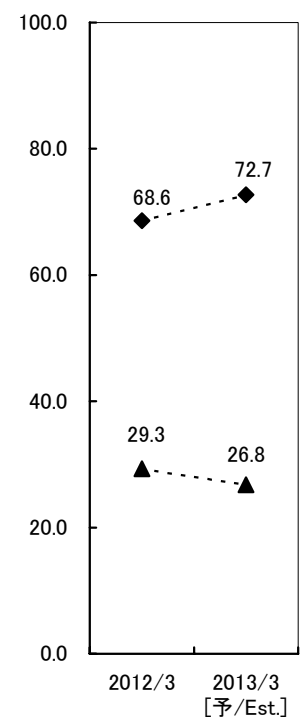

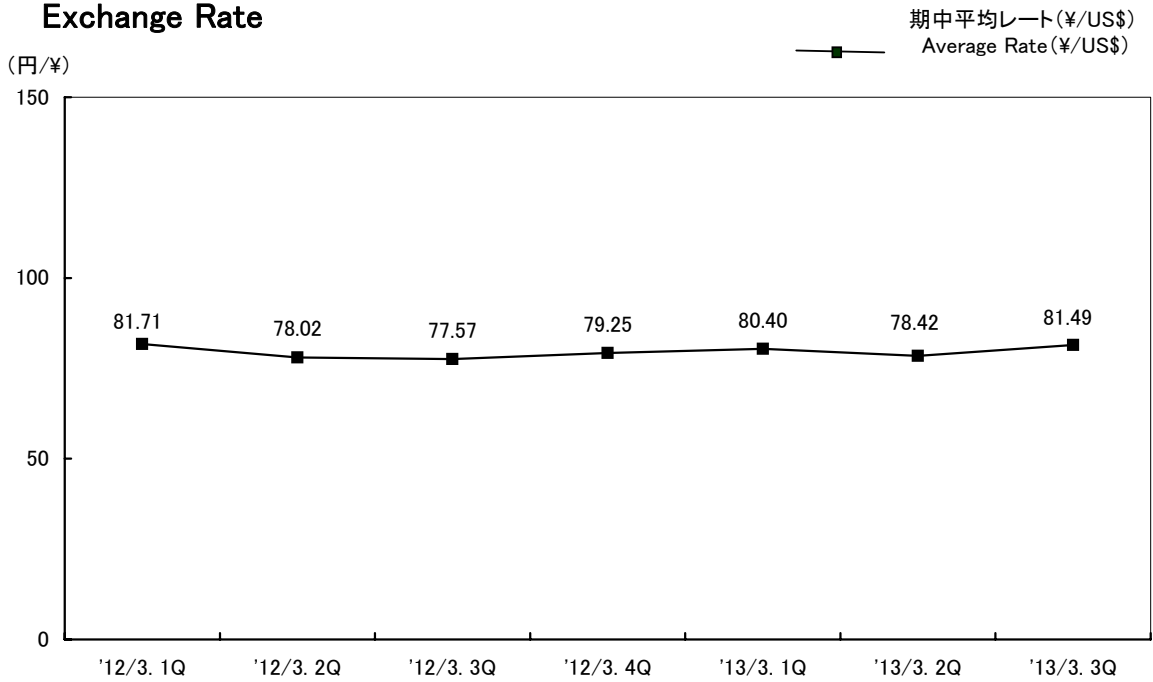

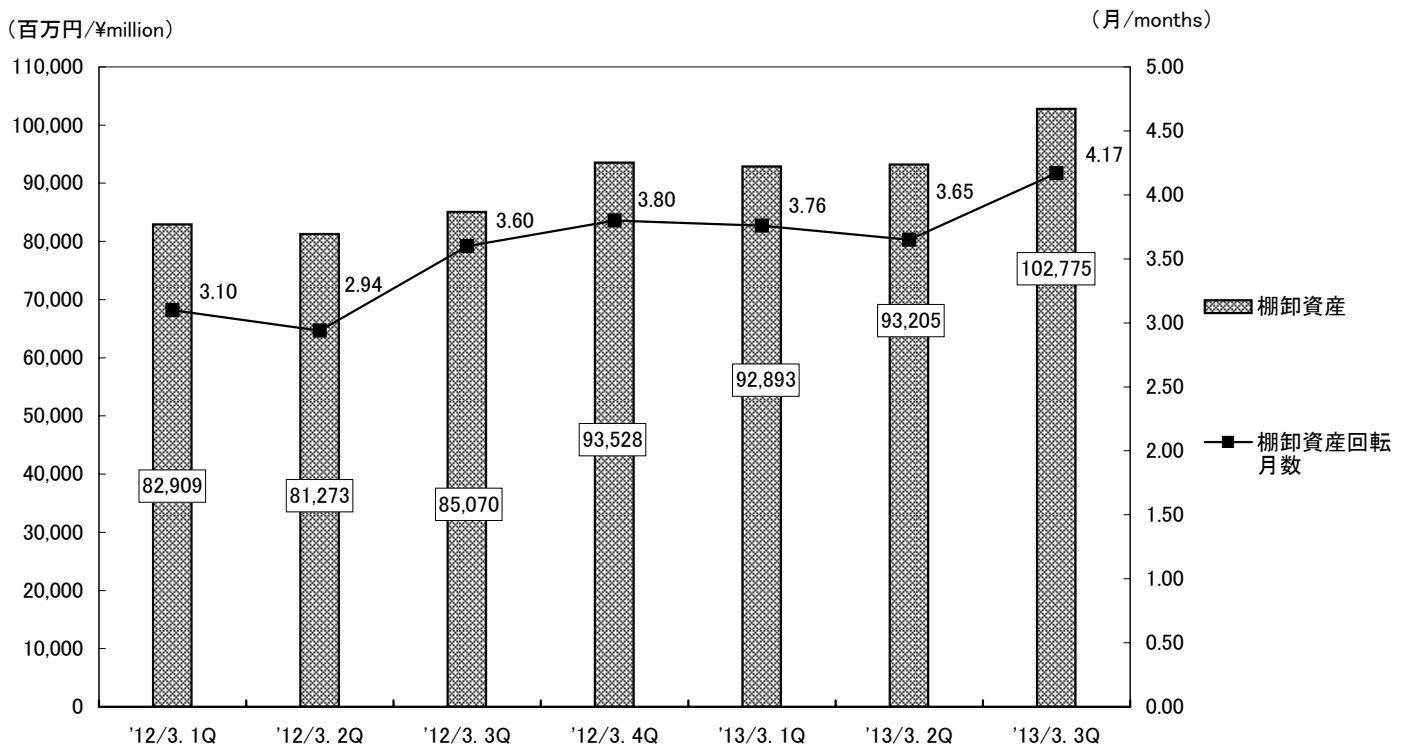

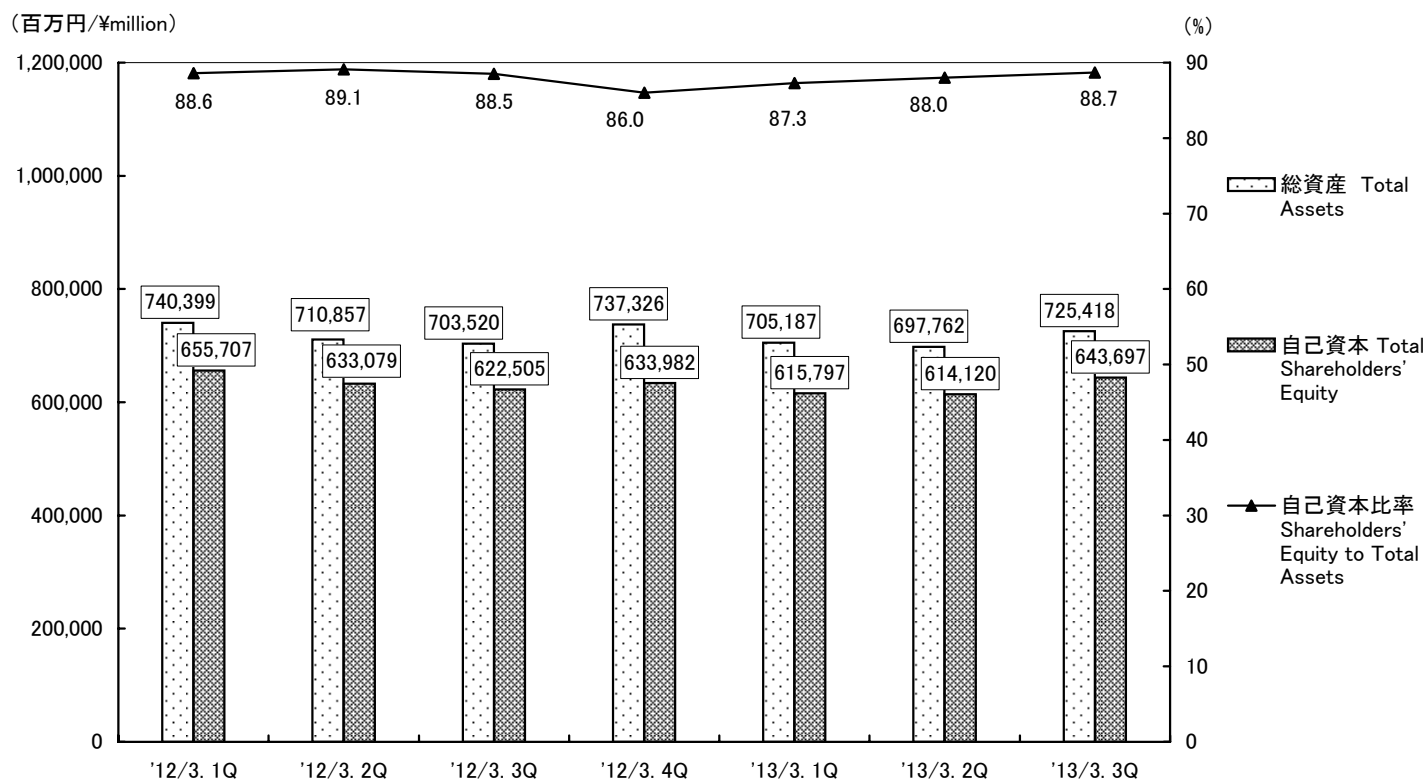

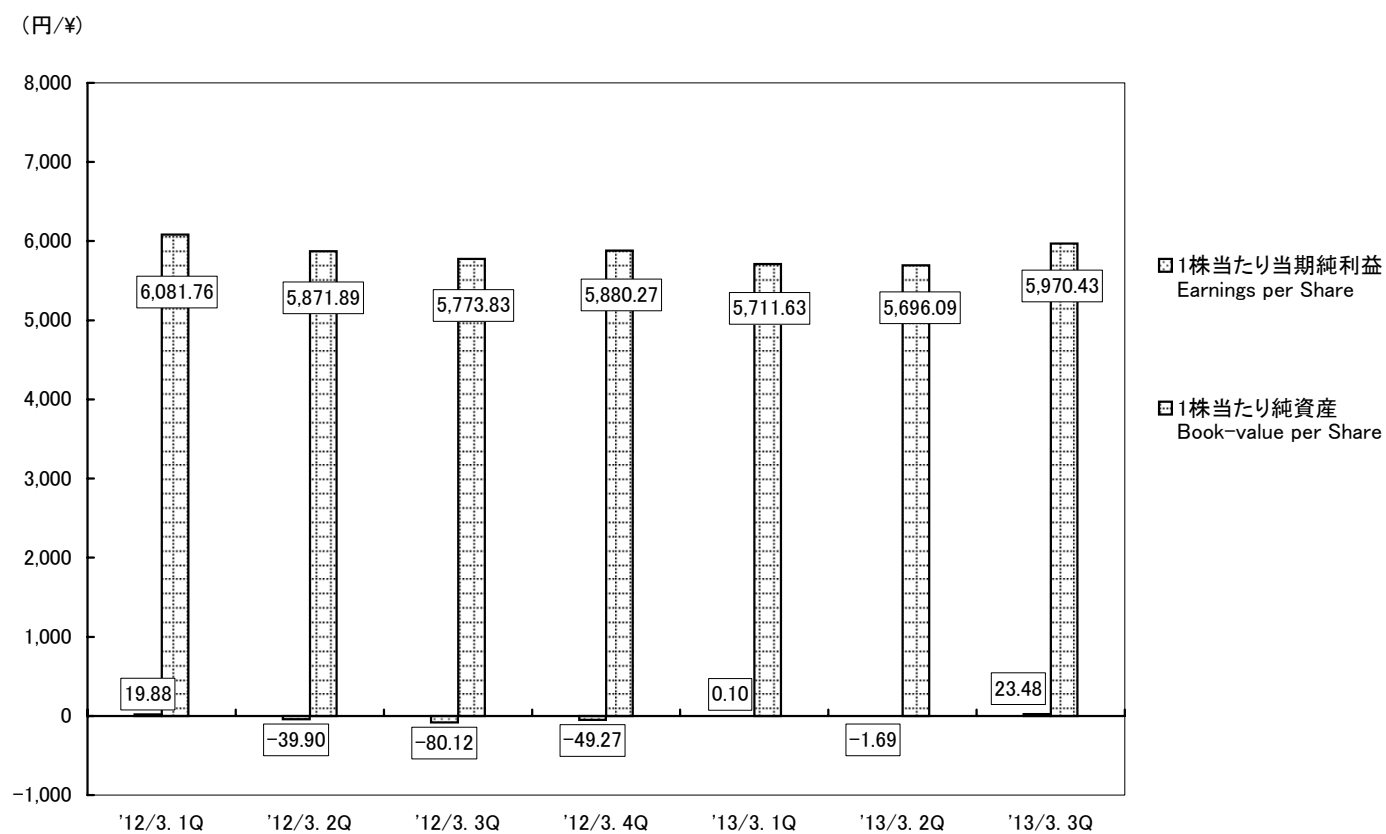
