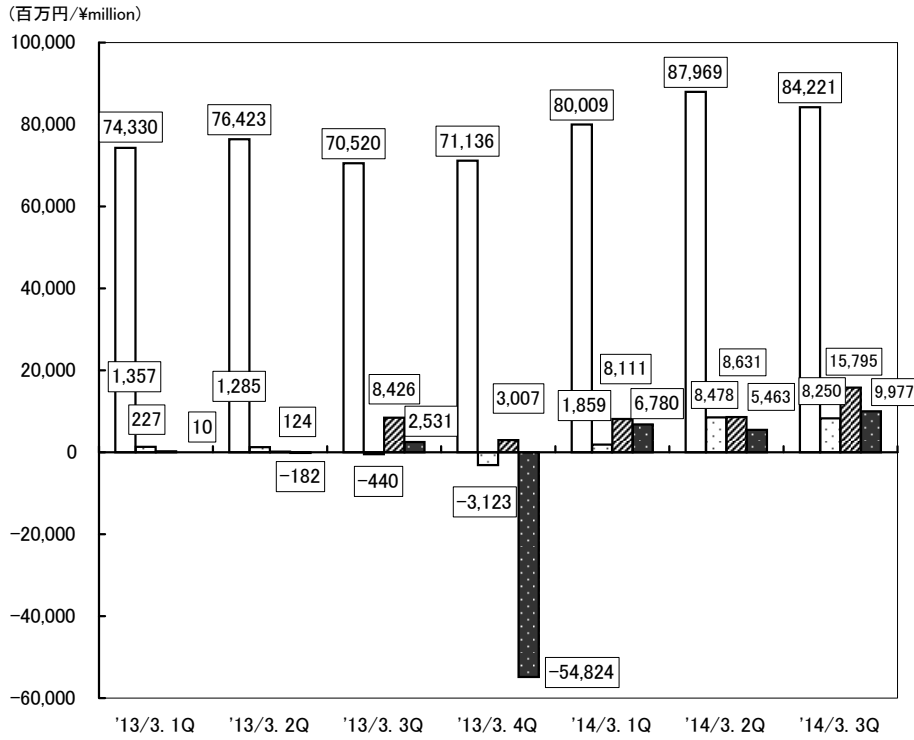

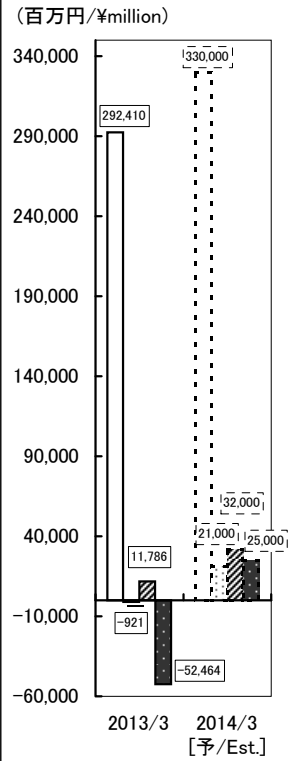

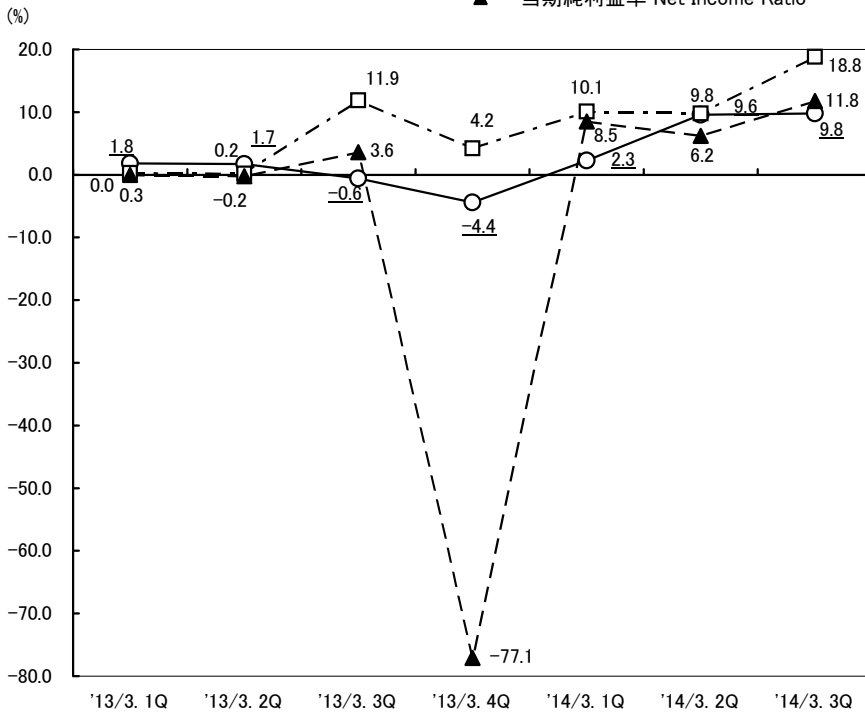


通期別推移 Annual Trend

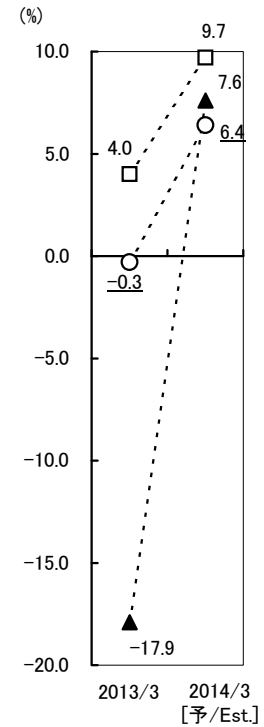

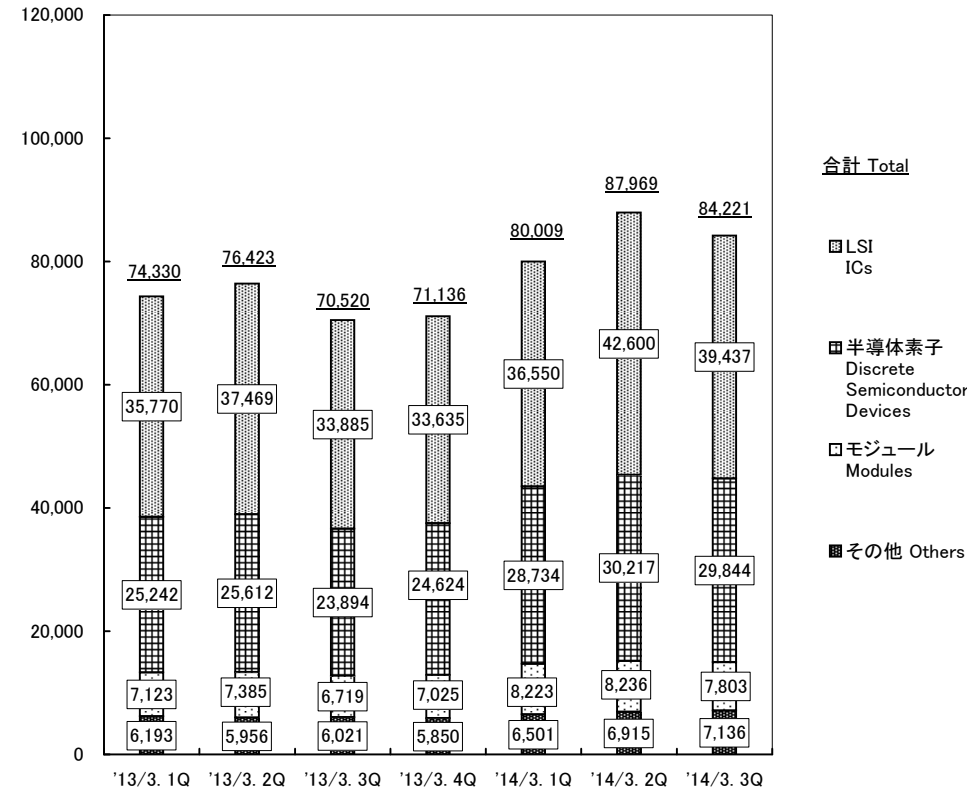

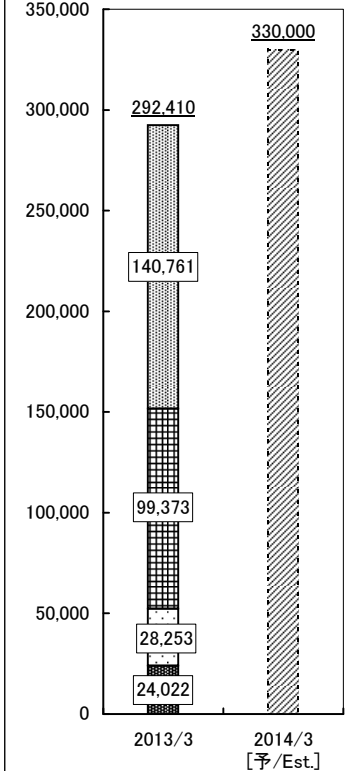
(1)セグメント別売上高 Sales by Segment

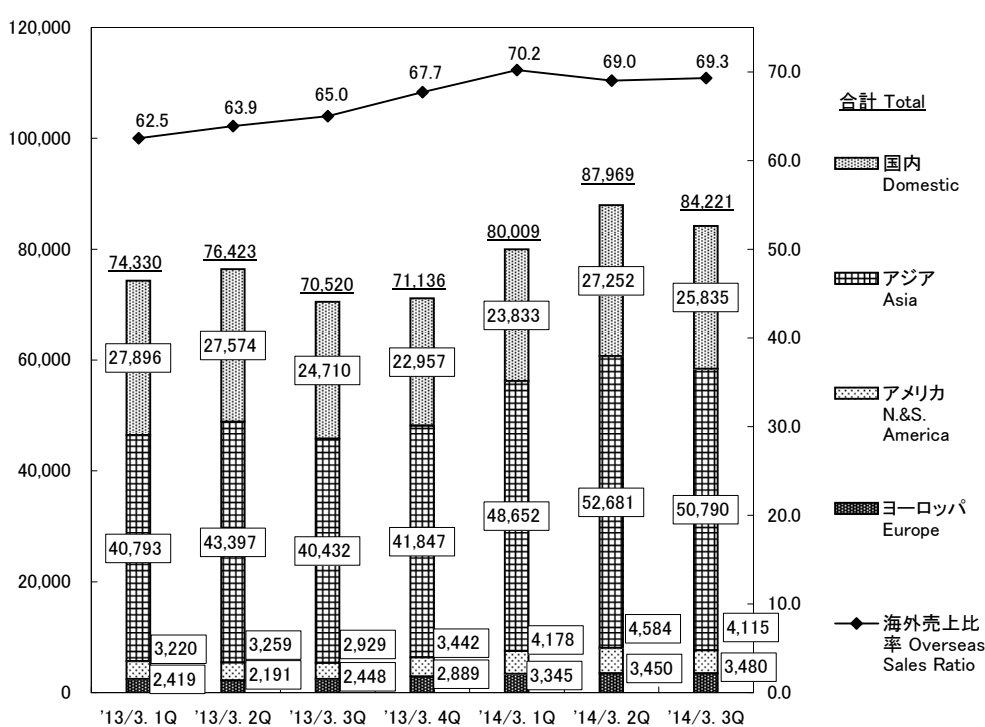

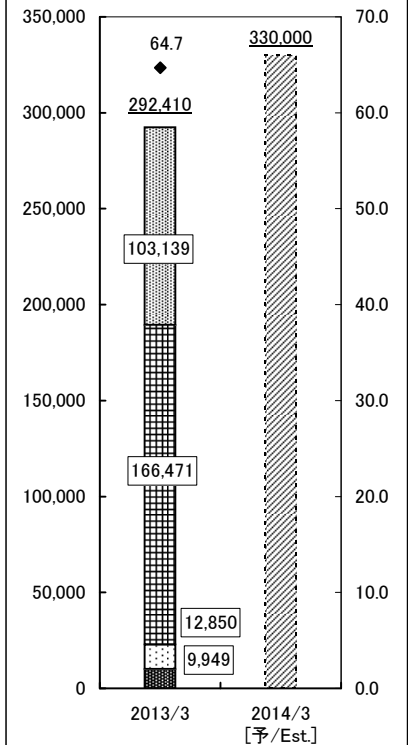
(2)地域別売上高 Sales by Region

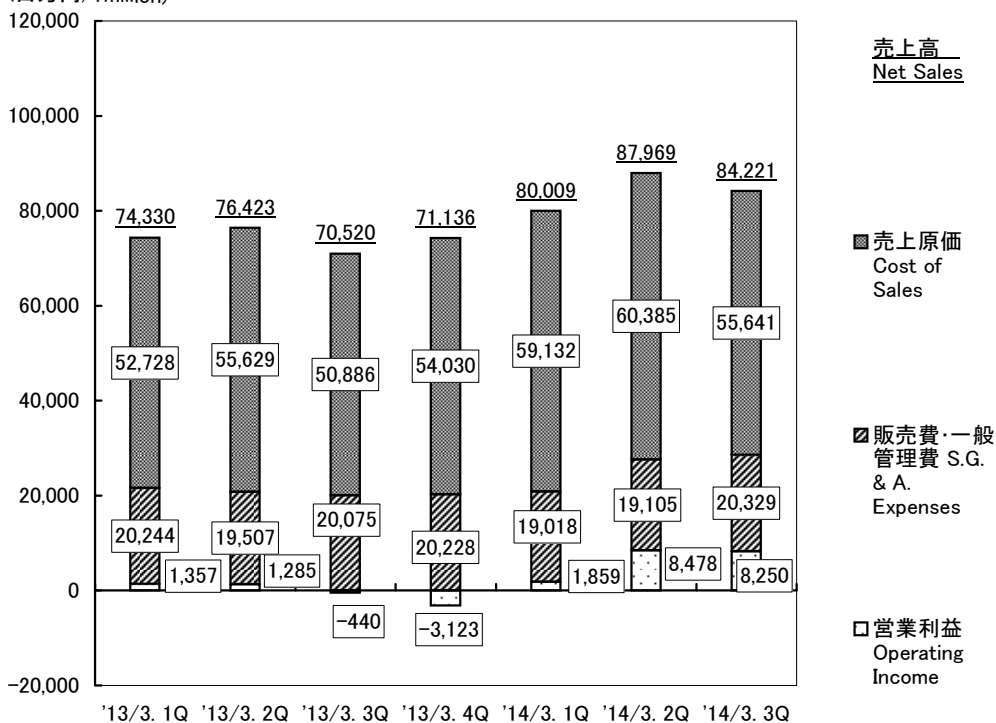

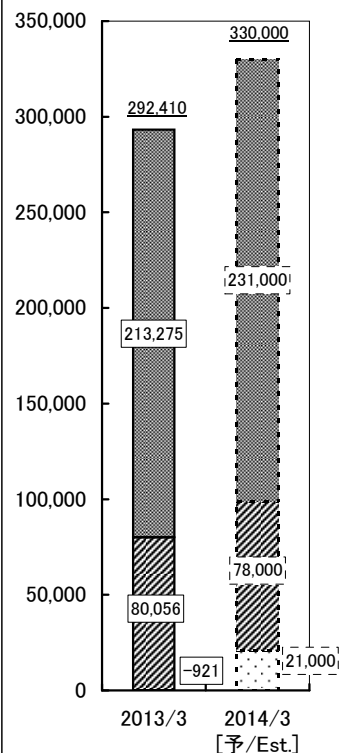

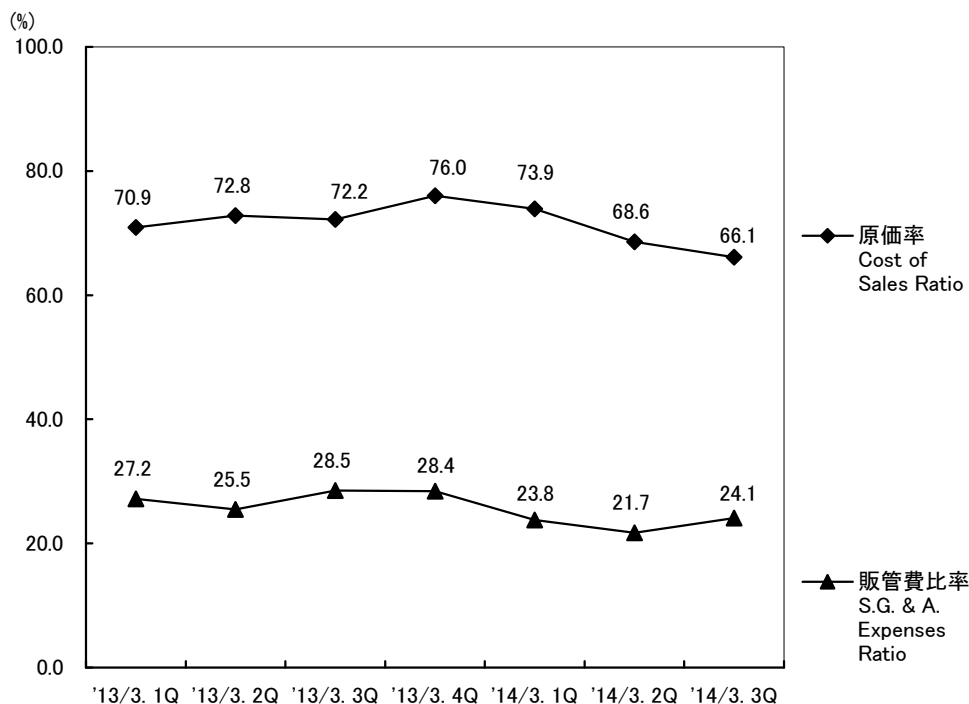
通期別推移 Annual Trend

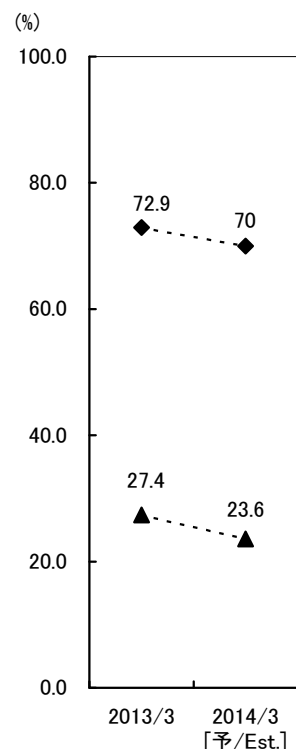

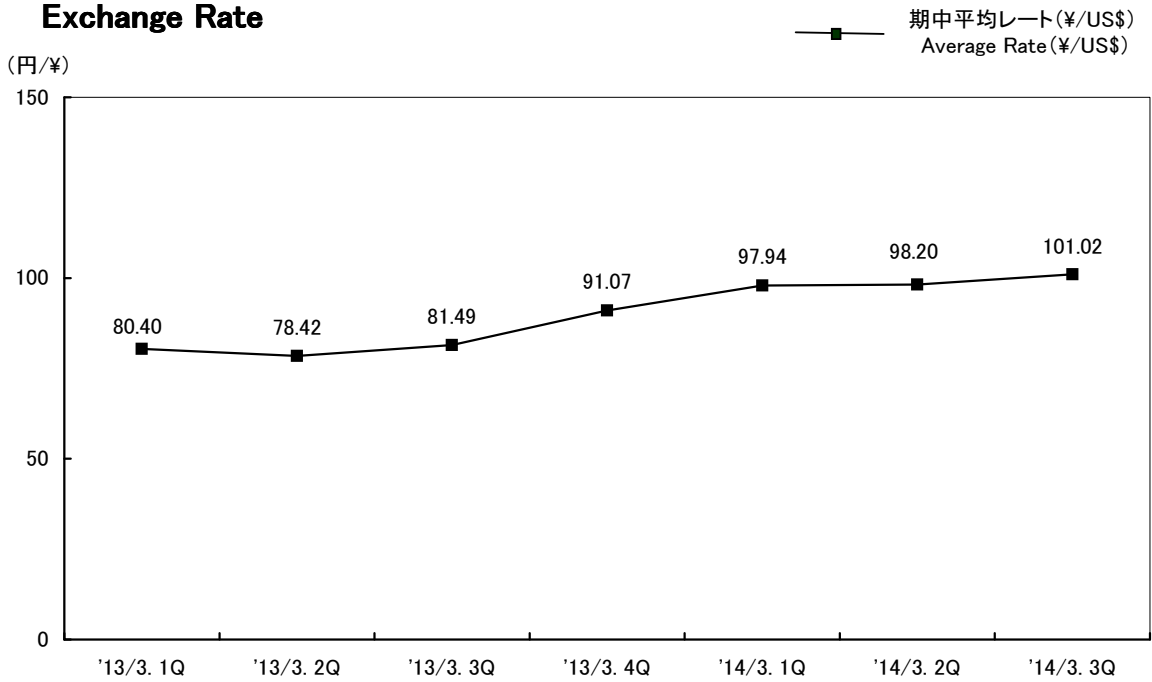
Cost of Sales as % of Net Sales / S.G. & A. Expenses as % of Net Sales



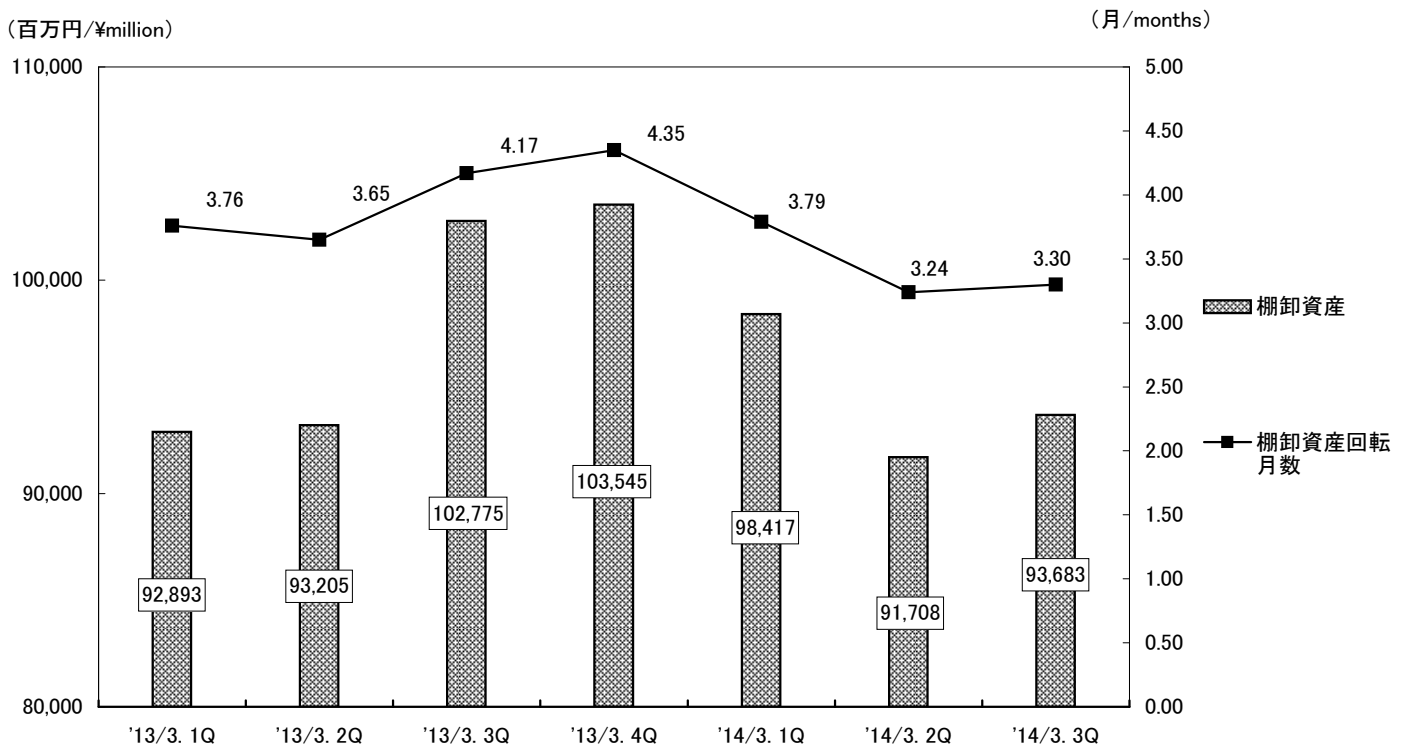

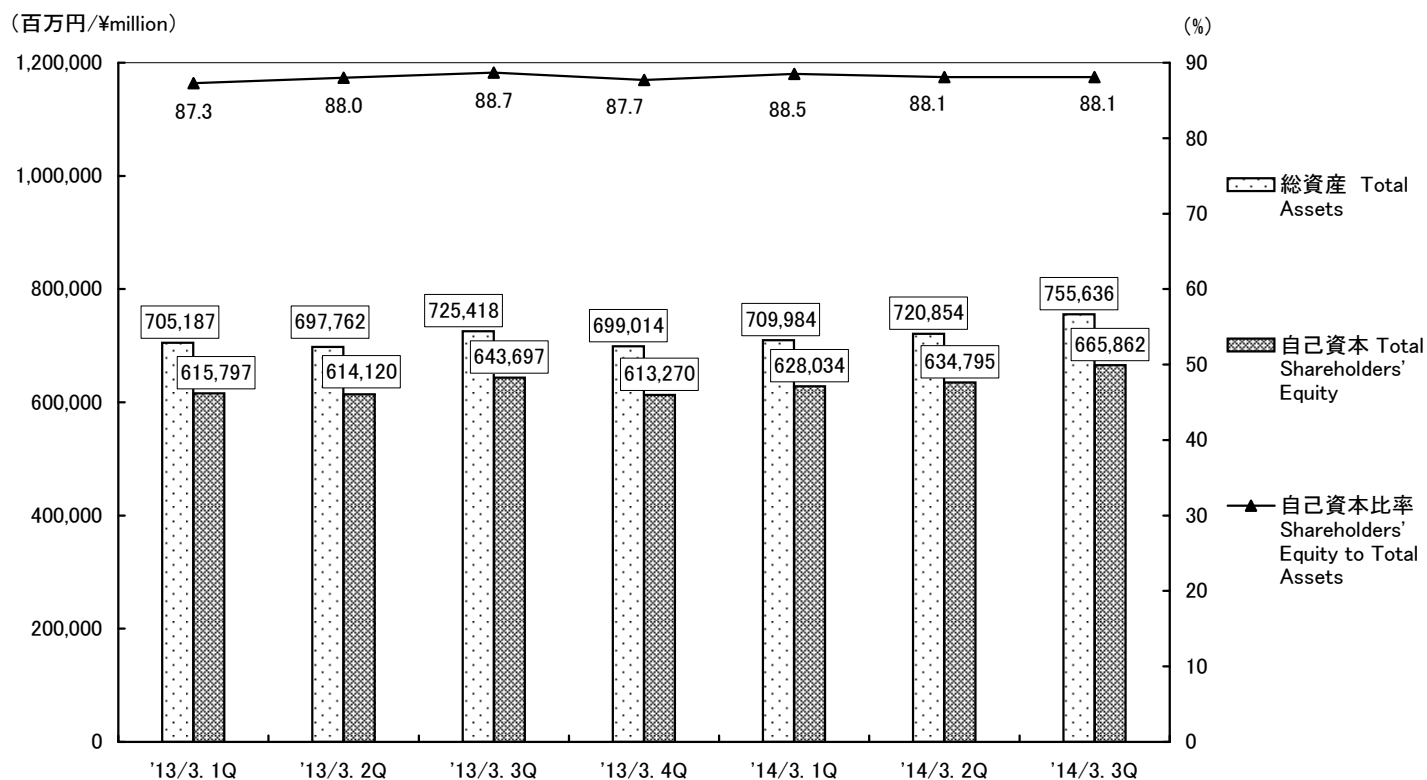

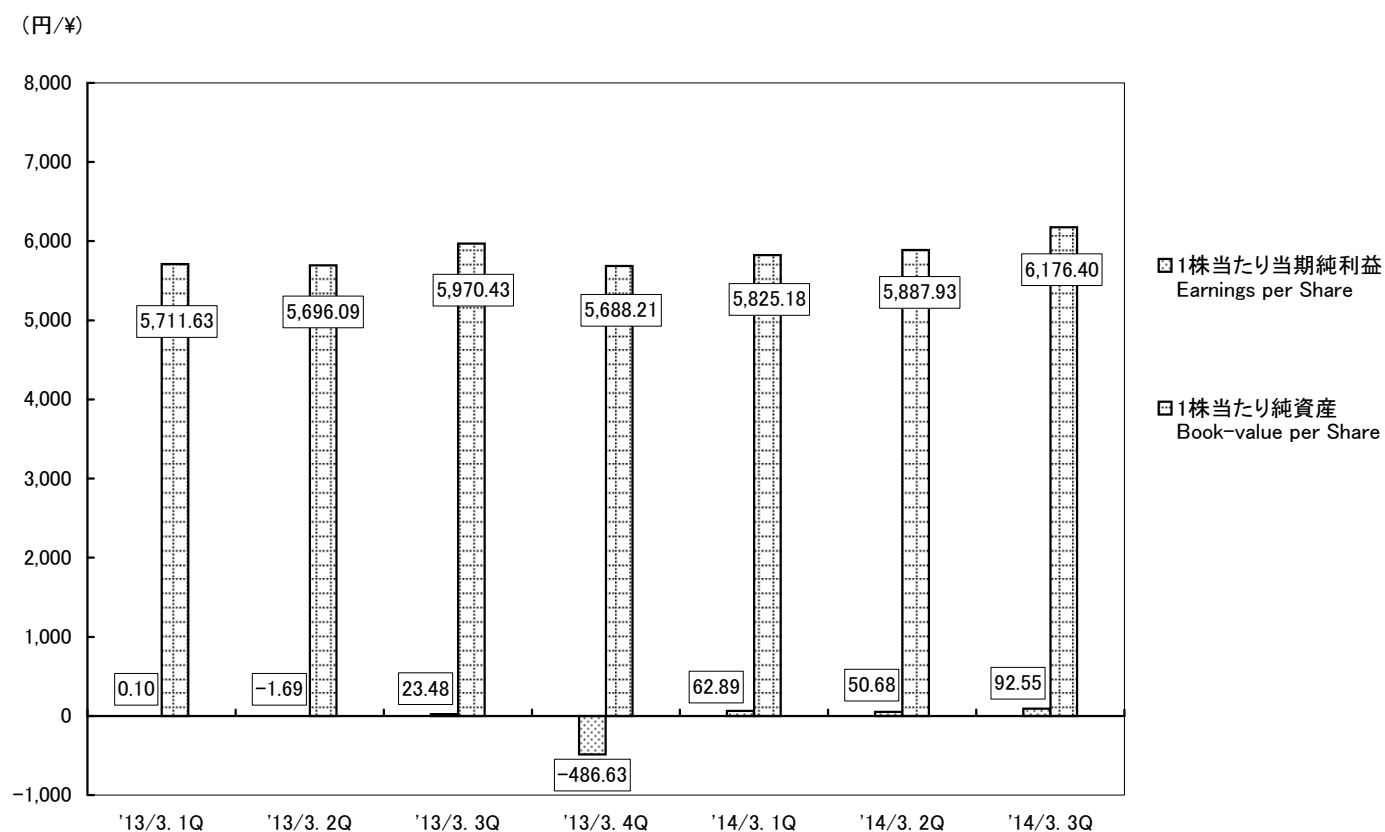
