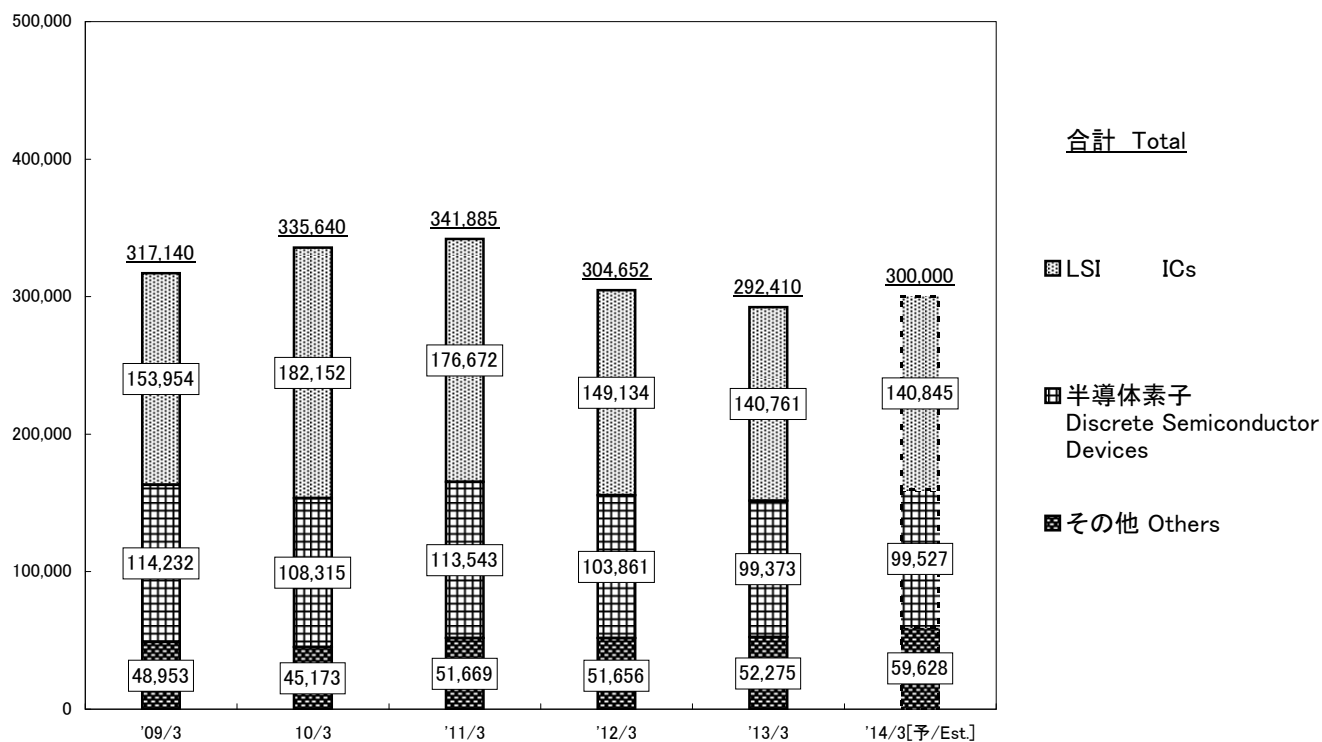

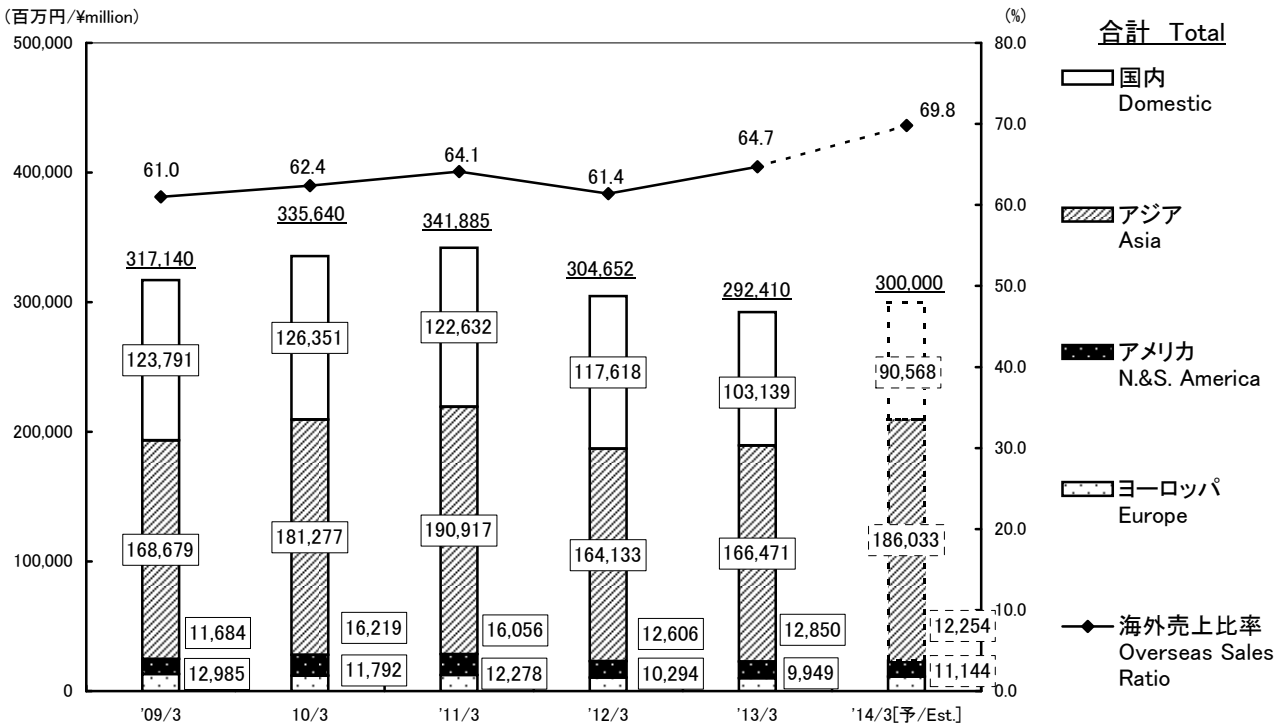
### (1) セグメント別売上高 Sales by Segment

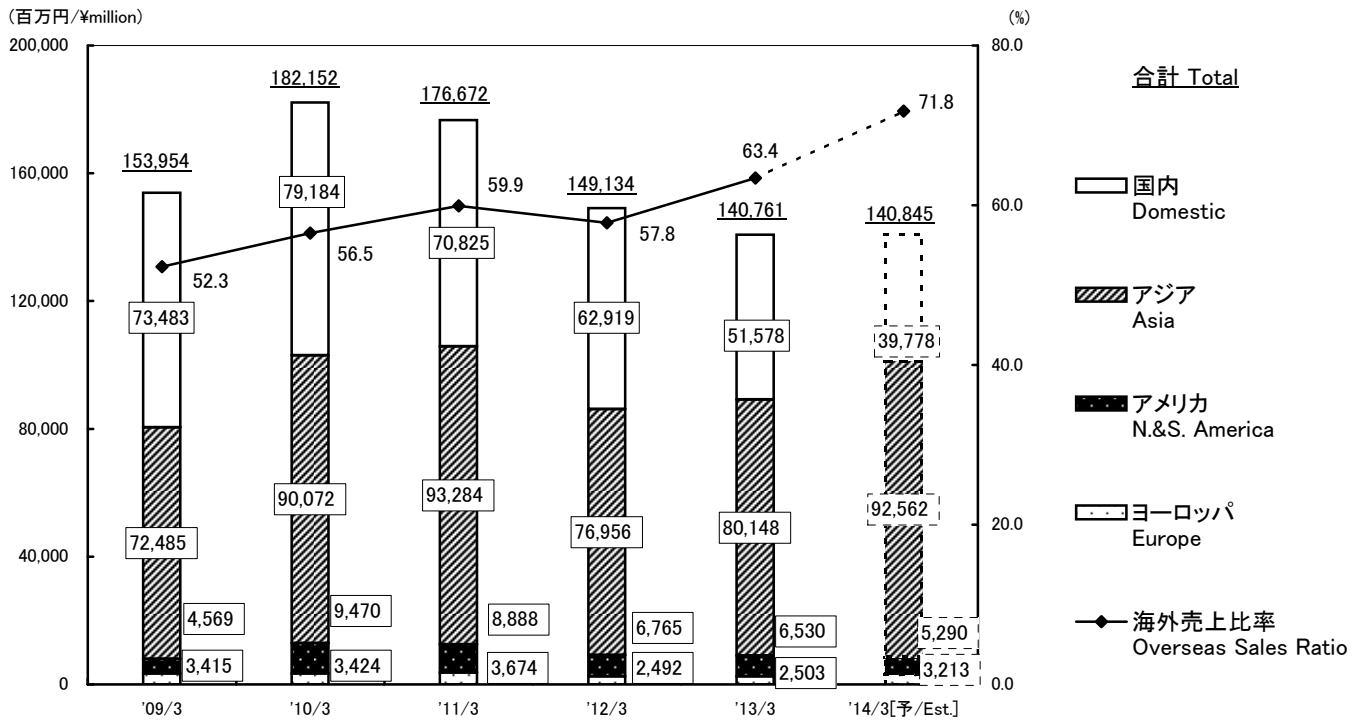


### (2) 地域別売上高・海外売上比率 Sales by Region/Overseas Sales Ratio

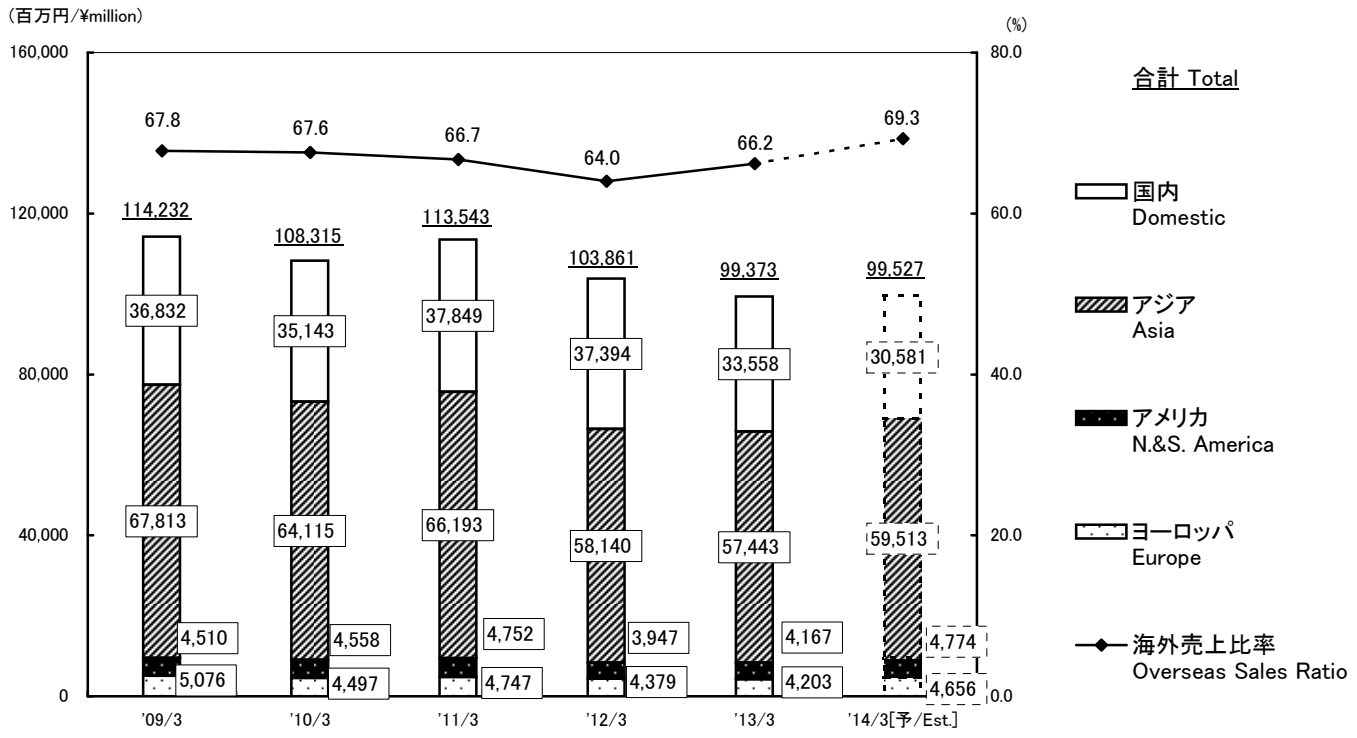

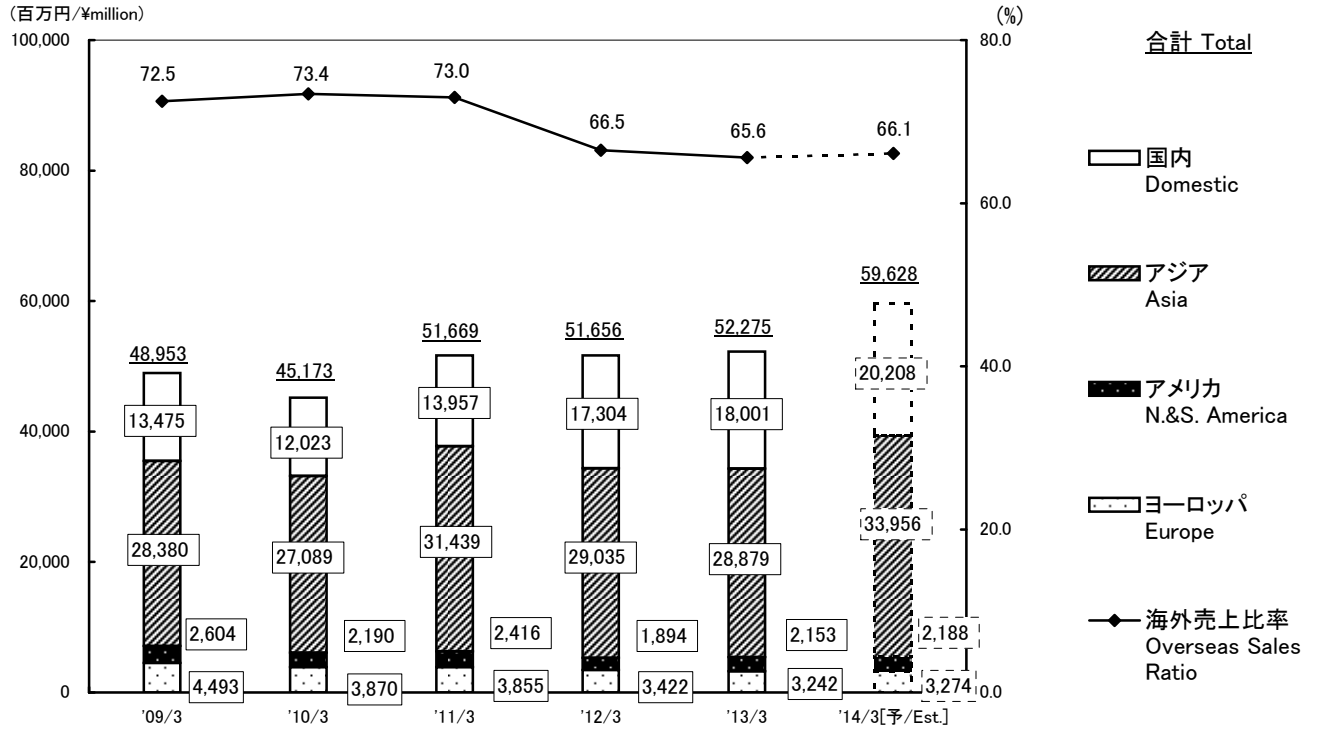
### (3) LSI 地域別売上高 ICs Sales by Region

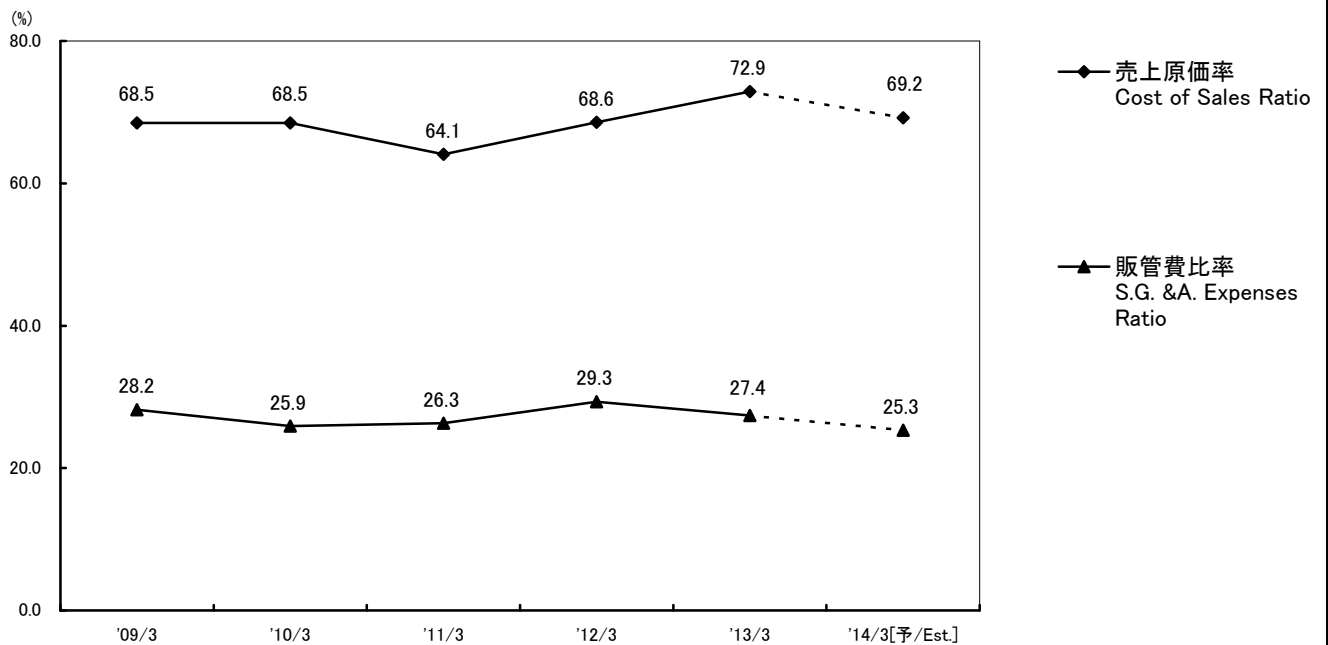

#### (2) 売上原価率・販管費比率 Cost of Sales as % of Net Sales /S.G.&A. Expenses as % of Net Sales

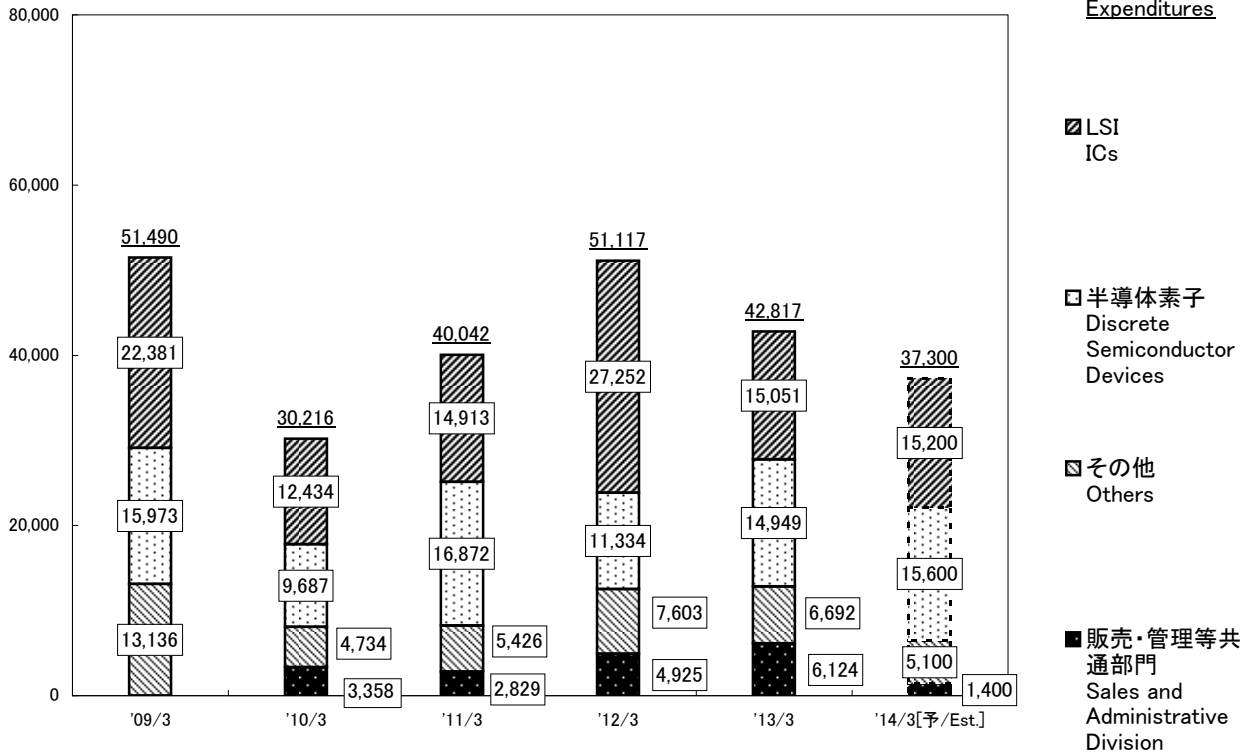

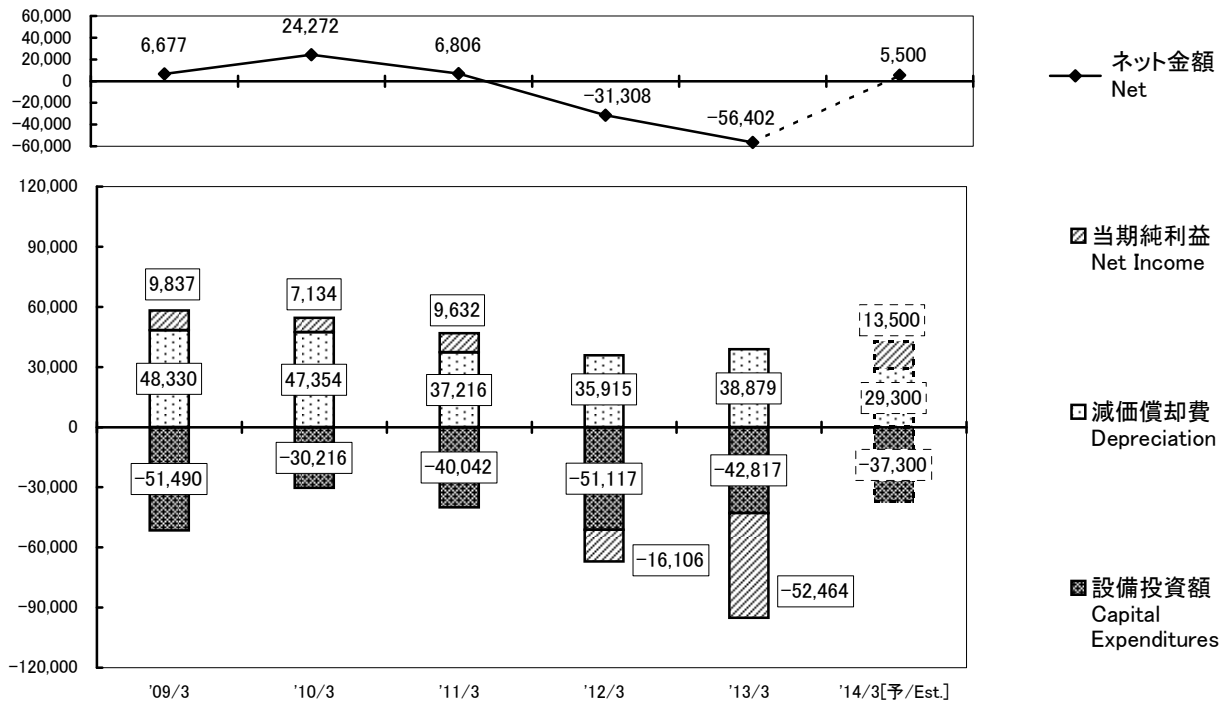

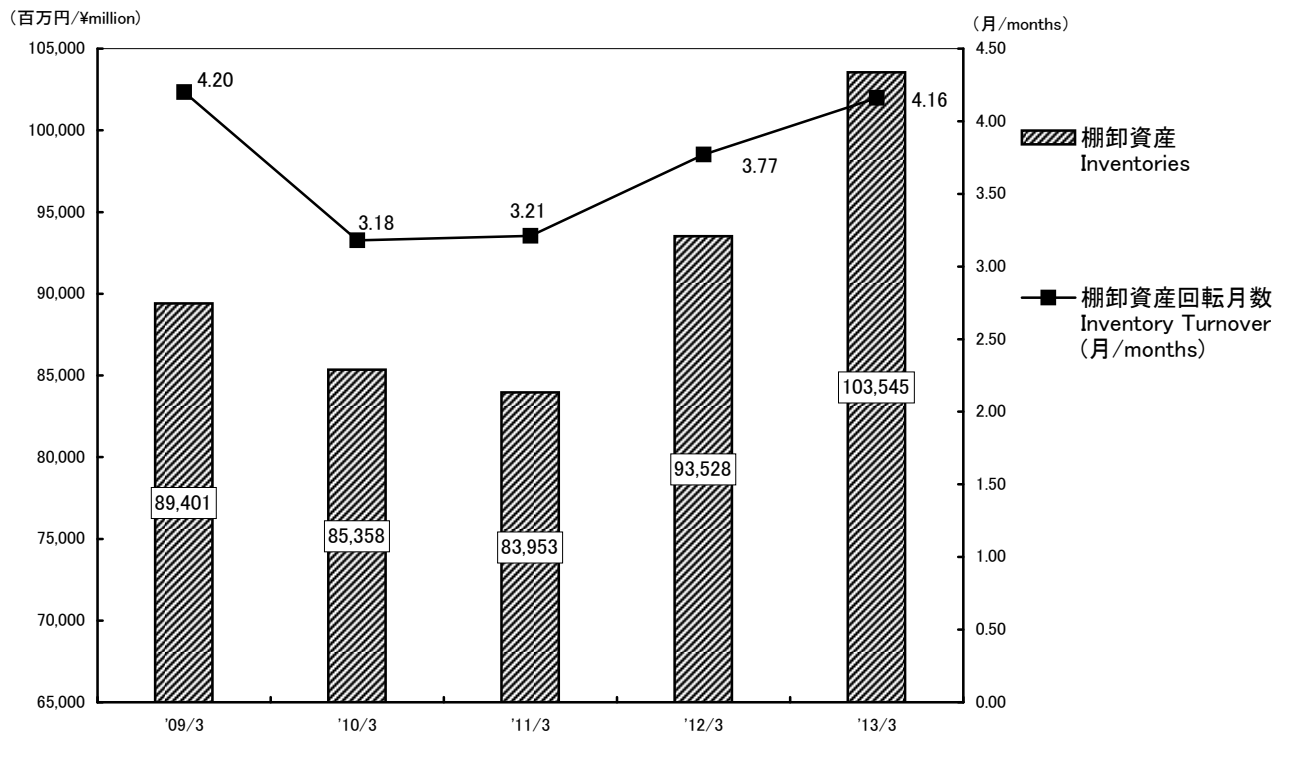

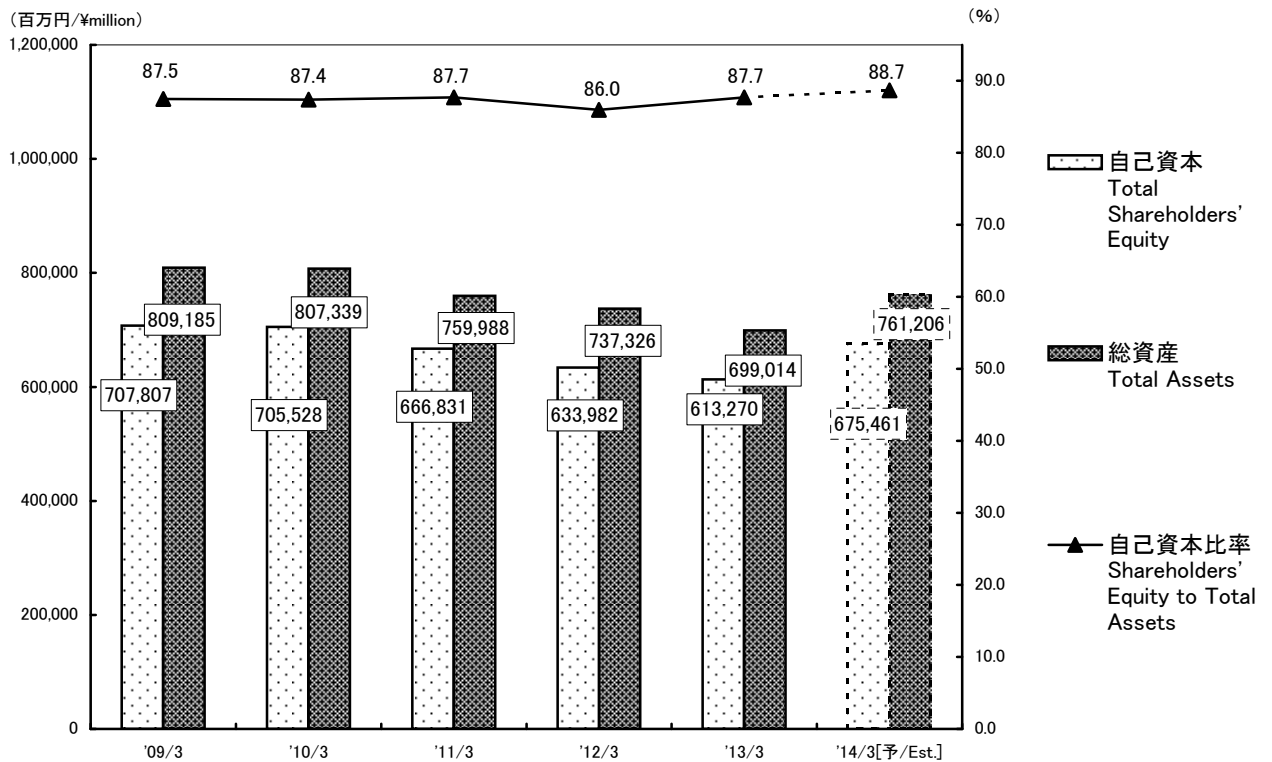

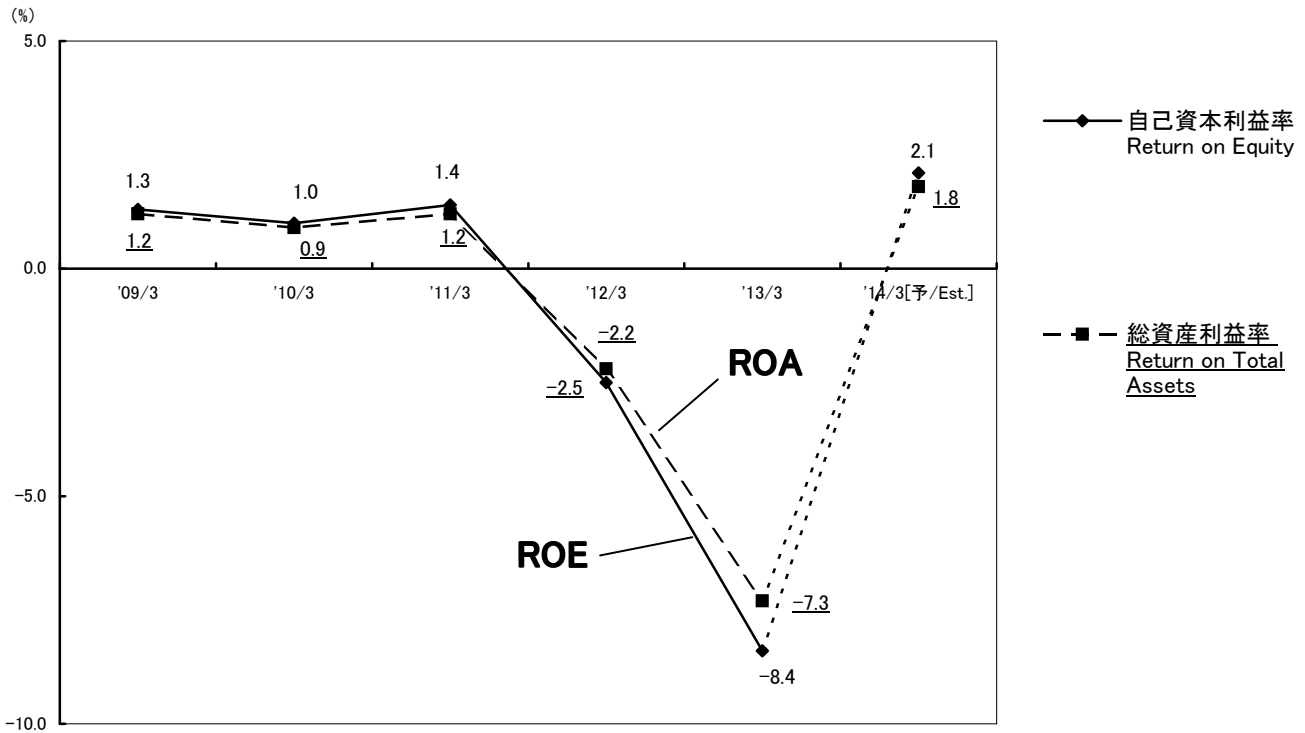

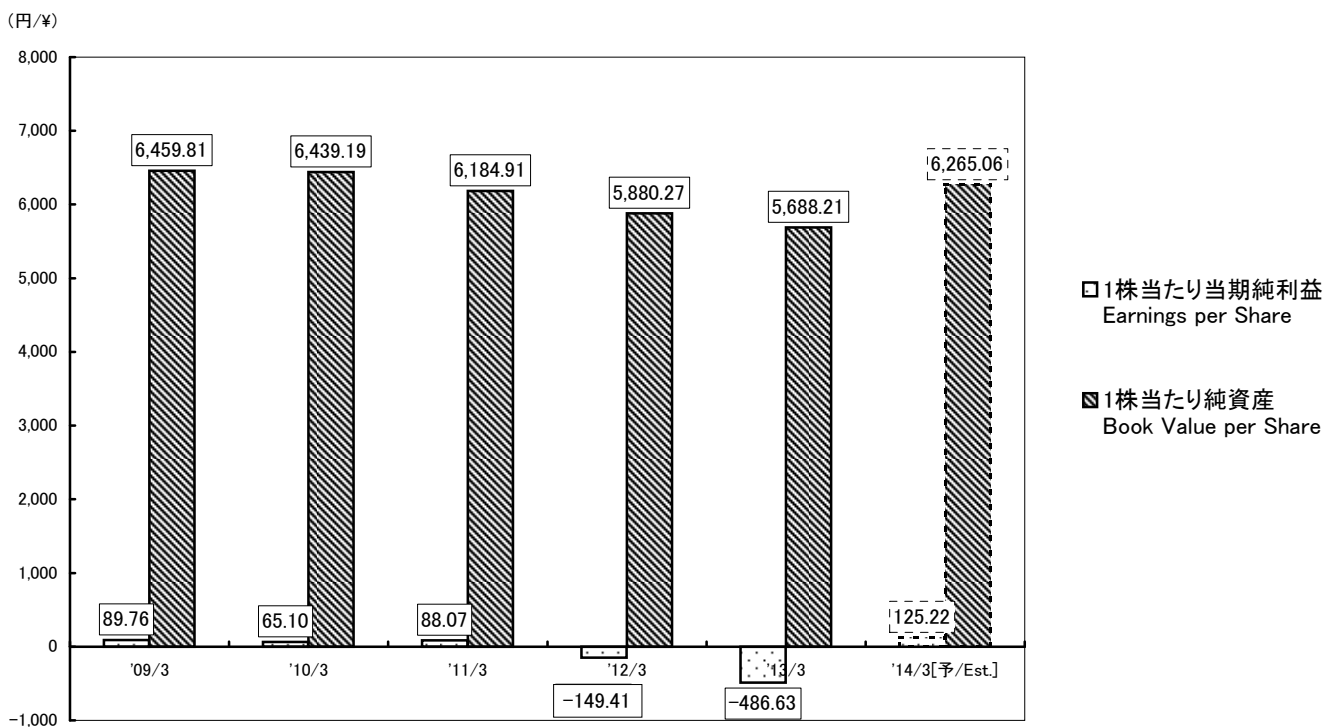

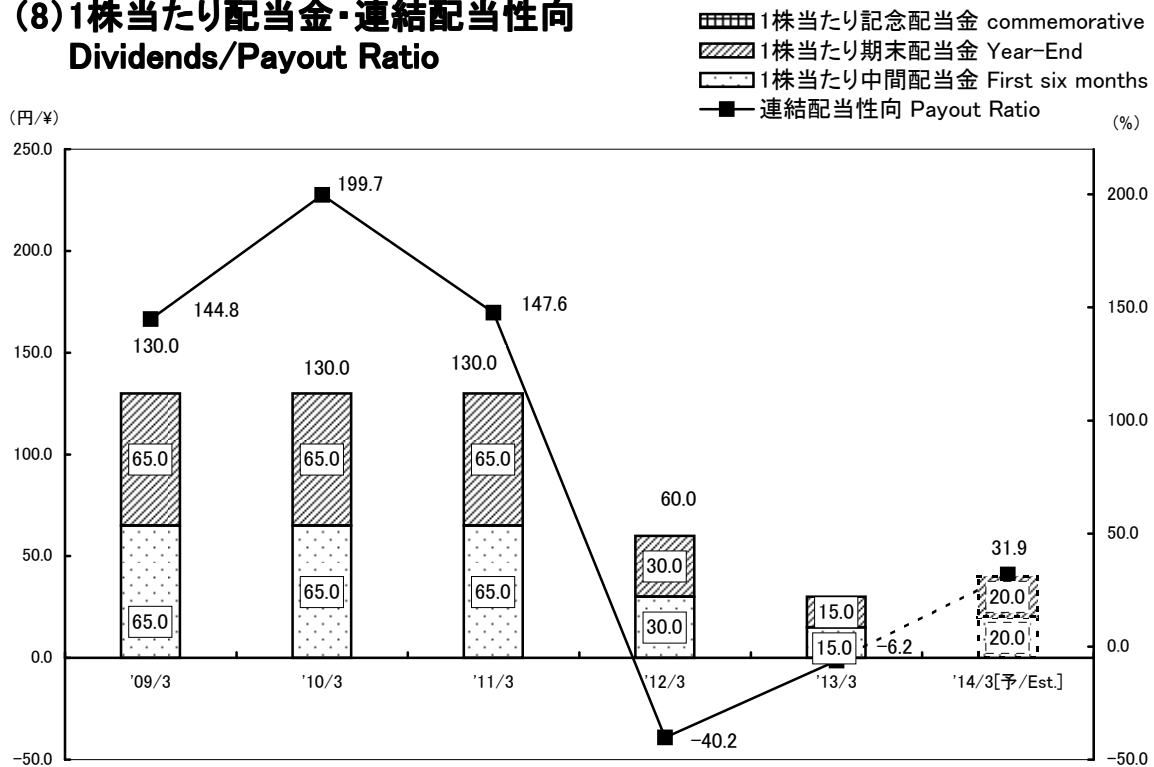
